

And Then Smiled And Drove Off Down The Road. Mr. Chism Immediately Called His Attorney Roy Miller, So That He Could Have The Ones That He Is Not Responsible For, Returned To The Sheriff's Office. It Is Clear That These Are Acts That Could Be Motivated By Some Type Of Emotional Trauma. It Is Easy For Anyone To See That We Have A Problem Here, Where There Is An Outright Intent To Disturb Another's Peace. And Then To Follow It Up, To Cite The Holy Tabernacle Ministries, United Nuwaubian Nation Of Moors And The Concerned Citizens Of Eatonton? Ask Yourself, Does This Not Imply All The Members Of These 2 Organizations And All The Concerned Citizens Of Eatonton Are To Appear In Court? Now What's Going To Happen When All Of The Members Of These 2 Organizations Are Informed To Show Up On January 5, 1999 At 9:00 A.M. Before Judge James L. Cline Jr., At The Putnam County Superior Court From All Over The World? He Summoned 2 Organizations, The Concerned Citizens And 3 Individuals. It Is Very Clear That This Was Not Thought Out Properly, And That The Office Of Adams & Ford, LLP, Dorothy J. Adams, Georgia Bar No. 000290 And Her Husband Francis N. Ford, Georgia Bar No. 268035, Should Reconsider This Motion In View Of The Fact That It Would Be Impossible To Summon 2 Organizations And All The Concerned Citizens That Live In Eatonton. Not To Mention, The Repeated Libelous Statements Launched Against Mr. York, Deborah Greene And John Wesley Carr, Who All Have Gotten Together With Their Attorneys On How To Deal With These Accusations Along With Mrs. Brenda Williams And The Legally Registered Board Members Of The Holy Tabernacle Ministries Inc.

The Point Is, This Case Seems To Be A Personal Attack By Sheriff Sills Against Mr. York. Again, How Long Will You Let This Go On? There Was Countless Untruths In It, And What Seems To Be His Real Reason, His Personal Reason, Is Shown At Least Three Times In His Motion For Injunctive Relief And For Damages. On Page 3, Number 12, Of The Motion, It States *Under The Masthead, Persons Believed To Be Members Of Tabernacle, Moors And CCE Placed A False News Article. "The Memberships Of These Associations Are Interlocking And Duplicative. York, Greene, And Carr Are Members Of One Or More Of These Organizations"*. There Is No Such Thing As A False "News" Article. Freedom Of The Press, And Freedom Of Speech Exists Under The United States Constitution, The First Amendment, Which Says: *"Congress Shall Make No Law Respecting An Establishment Of Religion, Or Prohibiting The Free Exercise Thereof; Or Abridging The Freedom Of Speech, Or Of The Press; Or The Right Of The People Peaceably To Assemble, And To Petition The Government For A Redress Of Grievances."*

The Georgia Constitution Article 1, Section 1 Paragraph V Also Ensures Citizens The Right To Print, Anything They Please. It States And We Quote: *"Paragraph V. Freedom Of Speech And Of The Press Guaranteed: "No Law Shall Be Passed To Curtail Or Restrain The Freedom Of Speech Or Of The Press. Every Person May Speak, Write, And Publish Sentiments On All Subjects But Shall Be Responsible For The Abuse Of That Liberty."* So Any Accusations Or Actions Against The Said Article, Is A Violation Of These Constitutional Liberties. On Page 3, Number 13 Of Sills' Summons States: *"York, At The Time He Sent The Enclosure At Exhibit B And The Message At Exhibit C, Knew Said Article To Be False And Knew That The Enclosure At Exhibit B Was Further False And Misleading In Its Representation That It Was The Legal Organ Of Putnam County."*

Stop And Think. If The Perpetrator Was Trying To Pass This Off As *The Eatonton Messenger*, Would They Call It *The Eatonton News*? You Can't Claim That Whoever Sent This Bogus Article, Was

Attempting To Make People Think It Was *The Eatonton Messenger*. But They Didn't Call It *The Eatonton Messenger*, They Called It *The Eatonton News*. The Word *Messenger* Has 9 Letters And The Word *News*, Has 4. There Is No Way In The World Any Intelligent Person Would Think That Those Two Words Are The Same Word. So The Person Or Persons Responsible For Sending This Article Never Intended To Imply That It Was *The Eatonton Messenger*. So The Case That They Attempted To Perpetrate This Article As *The Eatonton Messenger* Newspaper, Is Not Really A Case At All. York Does Not Reside At The Supposed Address The E-Mail Was Said To Have Been Sent From. York Did Not Send The Said E-Mail, And Again, Any Accusation Against The *False "News" Article* As Found On Page 3 Of The Motion Number 12, Is Trespassing On Constitutional Guarantees And Making A False Statement. So Again, It Is Trial, Plea, And Verdict Before A Trial, By Saying "York" *At The Time He Sent The Enclosure*, Without Indisputable Proof That, That Was York Himself Sending This Article. Then On Page 4, Number 16: *"Various Members Of Tabernacle, Moors, And CCE, To Include Greene, Have Attempted To Influence Various Local Media Outlets To Disseminate The False And Misleading Contents Of Exhibit B By Making Personal Visits To Said Media Outlets."*

He Is Going To Have To Prove That Mrs. Deborah Greene Was Involved, And Her Lawyer Has Already Assembled With The Lawyers Of Malachi, Chism And Greig, Because After Interviewing Her, And Finding Out That This Is A False Accusation, You Will Have To Produce Proof. You Will Not Get Away With It. Let's Just Dismiss Her, And Move On With The Case. Oh No, You Are Going To Have To Address, And Prove, Each Claim That Is Within The Pages Of Your Motion, Page 4 Number 16. You Will Not Get A Chance After Hiring An Old Friend To Alter These Changes, Or Add On What You Might Call More Evidence. No, You Are Going To Have To Prove Beyond The Shadow Of A Doubt, That Every Word That You Wrote Down There In Confidence, In Conviction, Is Truth Beyond The Shadow Of A Doubt And We Are Going To Work Together As You Appear To Work With Your Friends To Create This Situation. Again, **Is The Masthead The Issue Or Is The Article The Issue?** Any Accusation To The Contents Of Exhibit B, Or Said Article As False, Is Again, A Violation Of The Constitutional Guarantees Of Freedom Of Speech, And Press, Or Prove That They Are False.

Everyone Should Read The Paid Advertisement In *The Monticello News* Dated December 3, 1998, To See What The Big Fear About This Article Is. What Are They Afraid Is Being Revealed? And If There Is Nothing To Hide, Open The Case To The Public, As Most Other Divorce Cases Are. Make It A Matter Of Public Record For All To Read. We Repeat, If There Is Nothing To Hide. The Contents Of The Article Are Facts On Laws That The Sheriff Seems To Have Violated, And Is Someone's Opinion. But The Important Information And Statements That Were Pointed Out In Brenda Williams' Article, Seem To Be The Real Reason Why Sills Is Going Out On A Limb To Have The Article Smashed, And Keeps Taking The Attention Away From The Article And The Supposedly Phony Masthead. Think About It, And Then Ask Yourself Why? No, Don't Ask Yourself Why; Ask Them Why. They Went Into Malachi's Background And Falsely Broadcasted It. So Why Is It Unfair When We Concerned Citizens Ask The Same To Be Done To Them? SHERIFF SILLS. ATTACKS ON MALACHI CONTINUE.

On Dec. 15, 1998 Sheriff Sills Accompanied By Detective Lee Wilson, Drove Onto The Land Of Malachi York Or Dwight York, Or Which Ever Name Pleases You, In View Of The Fact That There Is An Obvious Intent To Ignore The Federal Government's Acknowledgments And Legal Acceptance Of The Name Malachi. So We Will Play This Kid Game With You. Be That What It May, Sheriff Sills Presented 4 Sets Of Papers To Thomas Chism. Here's How The Dialogue At The Gate Went. Sheriff Sills Pulled Up Between 9:48 A.M. And 10:00 A.M. In A Black Crown Victoria Car, License Plate Number 258 ERK, Putnam County And Was Out Of Uniform. The First Thing He Said Was:

Sills: (In A Sarcastic Manner) Tell Me Dr. York Isn't Here?

Chism: No He Isn't.

Sills: Are You The Spokesman Today?

Chism: Not Today, I'm Always His Spokesman.

Sills: Are You A Member Of The United Nuwaubian Nation Of Moors?

Chism: No.

Sills: (Baffled) You're Not?

Chism: No, Why?

Sills: (Repeat. Sure Sign Of Surprise) You're Not A Nuwaubian?

Chism: No. I Work Here. What's The Problem?

Sills: (Repeated 3rd Time) That's Not The Question Mr. Chism. I Just Want To Know Are You A Member?

Chism: I Said I Work Here.

Sills: Yes You Do Work And You Reside Here.

Chism: No I Don't.

Sills: (Baffled Again) No? But You Do Work Here?

Chism: Are You Referring To, Am I An American Citizen? Yes I Am, Born And Raised Here. Is This About My Religion Or Anything?

Sills: No.

Chism: Why Were You Asking What I'm About?

Sills: Because I Got Some Papers For The United Nuwaubian Nation Of Moors.

Chism: I Don't Know What That Is?

Sills: You Don't Know What That Is?

Chism: I Am An American Citizen. I Am The Spokesperson For Dr. York.

Sills: Okey Do Key (He Continues To Write And Sign The Papers).

Chism: What Is This About?

Sills: Its About An Injunction And Purporting To Be The Legal Organ Of Putnam County And Disseminating Certain Articles. I Appreciate It. Thank Y'all.

To Set The Record Straight, Thomas Chism Is A Seventh Day Adventist, An Adventist Christian, All Of His Life. He Is A 54 Year Old Man And Is A Member Of The Ancient & Mystic Order Of Melchizedek. That Is The Lodge Which He IS REPEATEDLY MENTIONED IN THE MEDIA. And Like Malachi, He Is Not A Member Of The Holy Tabernacle Ministries. What Mr. Sills Fails To See, Or Intentionally Pretends He Doesn't See Is, There Is More Than One Organization That Frequents The Land. Let Us List Them For You: 1. The Holy Tabernacle Ministries Which Is Legally Incorporated. This Is Something Mr. Sill's Injunction Denies Or Falsifies. 2. Then

There's The Ancient & Mystic Order Of Melchizedek. Also Legally Registered With The State Of Georgia, Certificate Number 117-99-01751-0. If You Look On Page 2 Under Number 5 Of The Complaint For Injunctive Relief And For Damages, It States: "*Holy Tabernacle Ministries (Tabernacle), United Nuwaubian Nation Of Moors (Moors) And Concerned Citizens Of Eatonton (CGE) Are Names Under Which Defendant York Conducts Business. They Are Also Unincorporated Associations Of Which York And Others Are Members.*" This Is Untrue.

Secretary Of State Corporation Division 315 West Tower 2 Martin Luther King Jr. Drive, Atlanta, Ga. Docket Number: 983420503, Control Number 9503490, Date Inc/Auth/Filed: 01/19/95, Jurisdiction: Georgia, Print Date: 12-8-98, Form Number 215 Reads: "*I, Lewis A. Massey, The Secretary Of The State Of Georgia, Do Hereby Certify Under The Seal Of My Office That The Attached Documents Are True And Correct Copies Of Documents Filed Under The Name Of Holy Tabernacle Ministries, Inc. A Domestic Nonprofit Corporation. Said Entity Was Formed In The Jurisdiction Set Forth Above And Has Filed In The Office Of The Secretary Of State On The Date Set Forth Above Its Certificate Of Limited Partnership, Articles Of Incorporation, Articles Of Association, Articles Of Organization Or Application For Certificate Of Authority To Transact Business In Georgia. This Certificate Is Issued Pursuant Of Title 14 Of The Official Code Of Georgia Annotated And Is Prima-Facie Evidence Of The Existence Or Nonexistence Of The Facts Stated Here.*" It Appears That Howard Richard Sills, The Sheriff Of Putnam County, Has On Numerous Occasions, Violated County Ordinances, And State Laws. Brenda Williams, A Concerned Citizen Of Eatonton, Wrote An Article Entitled "*Another One Of Sheriff Sills Ploy To Intimidate Malachi,*" About These Apparent Violations In Defense Of The Nuwaubians. This Article Was Printed In *The Monticello News*. As A Paid Advertisement On December 3, 1998. Somehow, This Article Ended Up On The Internet As A Part Of The Official Organ Of Putnam County Newspaper. When The Sheriff Found Out, And Obviously Read This Article Which Points Out His Misconduct, He Decided That He Must Put A Stop To This Article.

So On December 15th, Sheriff Sills Summoned Dwight York, John Wesley Carr, Deborah Greene, Holy Tabernacle Ministries, United Nuwaubian Nation Of Moors, And Concerned Citizens Of Eatonton To Court As Stated In The Dec. 16, 1998, Of *The Macon Telegraph* Article Entitled "*Judge Orders Nuwaubians To Silence Fake Newspaper,*" "*To Prevent Someone From Illegally Purporting To Be The Legal Newspaper...*" And *The Union-Recorder* Clearly Reads "*Judge Bans Use Of Fake 'Legal Organ' By Nuwaubians.*" These Headlines Imply That The Nuwaubians Have Been Found Guilty When They Haven't Had A Hearing Yet. This Presumption Of A Trial, That Hasn't Happened Yet, Puts In The Mind Of The Public That The Nuwaubians Are Guilty Before Proven Guilty, Making It Impossible For Them To Get A Fair Hearing Or Trial In Putnam County Courts. So This Case Will Also Have To Be Moved To A Superior Court And Presented Before A Jury So That Both Sides Will Be Able To Present All The Evidence, Videos, And Documents To Prove The Innocence Of The Accused.

However, It Is The Point Of This Flyer To Prove That This Case Is, Firstly Based On Lies, And Secondly, That It Is Sheriff Sills' Personal Response To The Contents Of The Article And Not The Words "*Official Organ*" Or "*Legal Newspaper,*" Which *The Union Recorder* Or *The Macon Telegraph*, Have Yet To Address, That Is, The Content Of The Article By Brenda Williams To Set Another Record Straight. Malachi York Or Dr. York Or Dwight York, Is Not A Board Member Of The Holy Tabernacle Ministries And Never Was. A Little Research

Into The Docket Number Would Have Shown That, Nor Is He A Registered Member Of The Holy Tabernacle Ministries.

Now, We Reiterate, The Statement By Sheriff Sills On The Complaint For Injunctive Relief And For Damages On Page 2 Number 5, Of Case No. 98-CV-393-12, Issued 2:05 P.M., Dec. 14, 1998 As Sheriff Sills, In His Capacity Of Sheriff Putnam County, Plaintiff Vs. Dwight York, John Wesley Carr, Deborah Greene, Holy Tabernacle Ministries, United Nuwaubian Nation Of Moors, And Concerned Citizens Of Eatonton, Defendant, Where He Clearly States That On Page 2 No. 5, They Are Also Unincorporated Associations Of Which York And Others Are Members. These Are False Statements They Are Slanders And Libelous. In Associating York As A Member, And Not Merely A Member, But The Head Of The Holy Tabernacle Ministries (Incorporated), Puts Him In Danger To Suffer Immediately And Irreparable Injuries. Loss. Or Damage. And This Has Been Filed With Mr. York's Attorney, Repeated Threats On His Life And Even The Reported Manager Of The Captain D's Restaurant In Milledgeville Called And Informed A Member Who Informed Malachi, To Warn Him That She Had Received Death Threatening Calls Towards Malachi. Because It Has Been Circulated That Malachi Frequents Captain D's. These People, Under Subpoena, Will Testify To These Facts. In Fact, The Sheriff's Office Has Been Called On Several Occasions About Physical Threats, Drive-Bys, Prank Calls Threatening His Life And The Likes. These Also Should Be On Record In His Office.

So Again, False Allegations And Defamation Of Character, That Is To Defame Somebody, An Attempt To Remove Their Fame, Is In Itself, A Violation Of The Law. According To O.C.G.A Official Codes Of Georgia Annotated, Page 289, Case Law: "*David Vs. Macon Tel. Publishing Co., 93 Ga. App. 633, 92 S.E. 2d 619 (1956), 'Defamatory Words Must Refer To Some Ascertained Or Ascertainable Person And That Person Must Be The Plaintiff Though The Words Used May At First Sight Appear Only To Apply To A Class Of Individuals, And Not To Be Specially Defamatory Of Any One Member Of That Class, Still An Action May Be Maintained By Any One Individual Of That Class Who Can Satisfy The Jury That The Words Referred Especially To Himself. The Words Must Be Capable Of Bearing Such Special Application, Or The Judge Should Stop The Case. But Let Us Continue.*" Again, Malachi York Is Not A Member Of The Holy Tabernacle Ministries. Also Malachi Does Not Do Business Under The Concerned Citizens Of Eatonton. Again, This Is An Untruth. But That Will Be Dealt With In Court. Speaking Of Libelous, False Accusations, Slander, Endangerment And Defamation Of Character. 3. Then There's The United Egyptian Church And The Sisters Of Isis, Unincorporated. What Those People Don't Realize Is That There Are Offices In Tama-Re, Egypt Of The West, In Malachi's Name With Computers That Anybody Who Are Members And Non-Members, Are Allowed To Use Those Computers, For The Voluntary Work That People Do. Each Day, Many People Walk On The Land, Sign In As Volunteer Workers And Are Allowed Free Access To Work In Various Departments, Indoors, Outdoors, Construction, Office Work And The Likes. Any Individual Can Walk Over To A Computer And Send Anything They Want.

We Have To Remember That, It Was Admitted That York's Land Was Infiltrated, Which Is Stated On Sarah Wallace's Channel 7 News Report In New York, *Salvation Or Destruction*, Where She States "*Two Eyewitnesses Attended Undercover...*" And We Are Quoting From The Television Show. In View Of The Fact That It Appears That All Of These People Are In Cahoots, Bill Osinski, Sarah Wallace, And Sheriff Sills, Francis Ford, Sandra Adams, It Does Not Surprise Us That Something Like This Has Popped Up. This Is The Kind Of Underhanded Manipulative Activity That Goes On Between The Officials In Eatonton. If You Do Some Research Into Their Lifestyles And Into Their Past, You Will Be Amazed.

You Do Not Have To Be A Lawyer Or A Private Investigator. Anyone Can Go To The Court House And Bring Up A Name And Ask For The Minutes To Court Cases, Which Is Public Information, Photostat Them, And Take Them Home. Anyone Of The Cases That's

Under Lock And Key, Is Hiding Something. So Could This All Have Been A Part Of A Big Plot? Again, We Stand On The Fact That Anybody Can Or Could Have Sent That E-Mail And The Burden Of Proof Is On Them. This Is America. You Are Innocent Until Proven Beyond The Shadow Of A Doubt, That You Are Guilty. And With All The Publicity About Malachi And The Nuwaubians In Eatonton, By The Local Newspaper, And Television, All Charges And Trials Will Be Transferred Out Of This County And Out Of The Hands Of This Vicious Circle Of Friends, And Into The Hands Of Honest, Reliable Authorities.

That Is To Say, Just As In The Zoning Case All Of The Charges Pertaining To Chism, Greig, And Malachi, Are Being Transferred To Other Counties Where They Can Get A Fair Trial. There Will Be Evidence And Witnesses To Prove That Malachi Couldn't Possibly Have Sent That Email As #9 Of Sheriff Sills Complaints States On Page 3: "*On Or About Nov. 29, 1998 At 6:39 P.M., Est, York, Using The Identifier Aafert@aol.com Sent An E-Mail Message And Enclosure To Carr And Others.*" How Can You Make An Unquestionable Identification That York Did It, When Your Statement Says, And We Quote: "*On Or About November 29th At 6:39 P.M. Est.?*" The Only Accurate Part Of This Statement Is The Time "*At 6:39 P.M.,*" But The "*On Or About November 29th?*"

Does That Mean It Could Have Been The 30th, Or The 28th? Because It's Definitely An Uncertain Statement And Does Not Warrant A Fact Beyond Any Doubt. So Here It Is A Questionable Statement, Along With An Accurate Time. So Again, We Have More Inaccurate Statements, Because Malachi Did Not Send Any E-Mail Or Have Anything To Do With The E-Mail Being Sent At That Time From That Computer, And Can Produce, And Will Produce Up To 630 Or More Witnesses, To Prove That He Could Not Have Possibly Sent That E-Mail Because He Was Standing In Front Of Them, As He Does On Most Sundays From 3:00 P.M. Until After 8:00 P.M., Without Taking A Break, Constantly Answering Questions And Teaching. Are These Then, Going To Be Proven To Be False Accusations, In Light Of The Fact That All Of His Classes Are Video Taped From Beginning To End And Video Tapes Have A Time Code On Them? There Is More Than One Computer Hooked Up To The Same Line As You May Or May Not Know. That Anybody Who Has Your Password And Screen Name, Can Plug The Computer In From Any Place And Go On Line. So A Trace Of The Telephone Records And From Whence Calls Were Placed, Would Make It Possible To Know Exactly Where The Article Was Mailed From. Then Tying Malachi Into That Computer On Nov. 29, 1998 At 6:39 P.M., Is Going To Have To Be Proven And Will Be Proven To Be An Untruth. Even Though It Has The E-Mail Address And Name Of Aafert At The Bottom Of The E-Mail, The Password Is Available To Any For It's Taped On The Side Of The Computer For Easy Access.

So On The Date Of Dec. 15, 1998, Sheriff Sills Presented Mr. Chism With 4 Sets Of Papers, One Original, And 3 Copies, That He Signed While On The Property. After Being Told That He Is Not A Member Of The Holy Tabernacle Ministries By Mr. Chism And Not A Resident Of 404 Shady Dale Rd., He Persisted On, Stuffing Them In His Hand, Smiling And Driving Away. And All Of This Is On Video Tape As You Know, When Needed In A Court Of Law. They Listed Dwight York. After Mr. Chism Told Him '*I represent Malachi.*' Not His Son, Dwight York. It Listed A John Wesley Carr, Who After Reading The Motion Attached, Gives His Address As South Carolina, Not 404 Shady Dale Rd. Then It Lists A Ms. Deborah Greene And Gives Her Address As Macon, Georgia, Not 404 Shady Dale Rd. Yet, He Persisted On Giving These Documents To Mr. Thomas Chism After It Should Have Been Clear That He Was Not Responsible For These People, And If These People Don't Get These Documents, It Is Not The Fault Of Thomas Chism, But Sheriff Sills, Who Signed Them On The Spot On Video Tape. Then Before Sills Could Get Away, Mr. Chism Said: "*Chism: What Is This About? Sills: Its About An Injunction And Purporting To Be The Legal Organ Of Putnam County And Disseminating Certain Articles. I Appreciate It. Thank Y'all.*"
