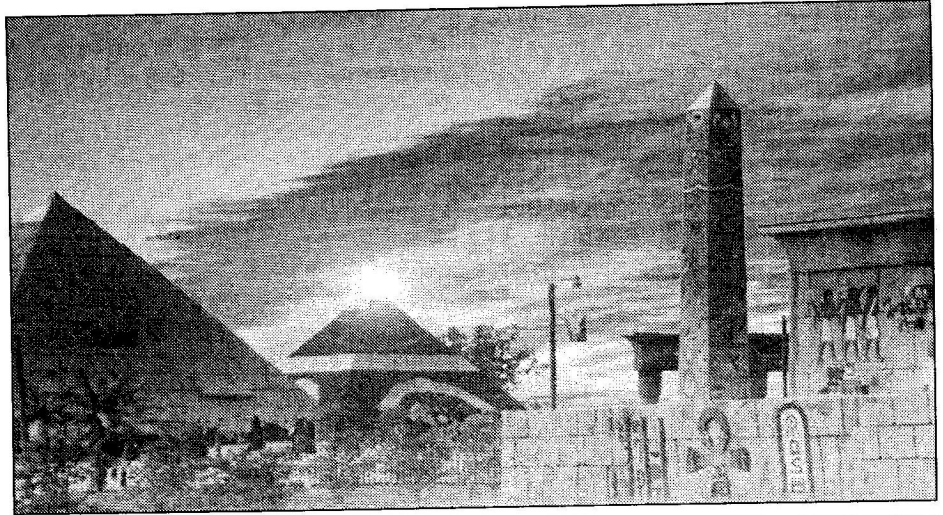


“April 27th” The Reverend Jesse Jackson speaks out in Putnam

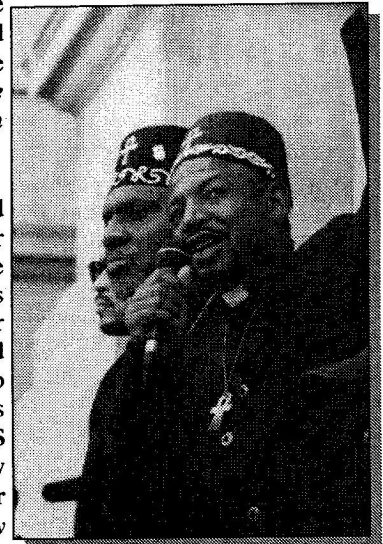
It's not over ! It just begun !



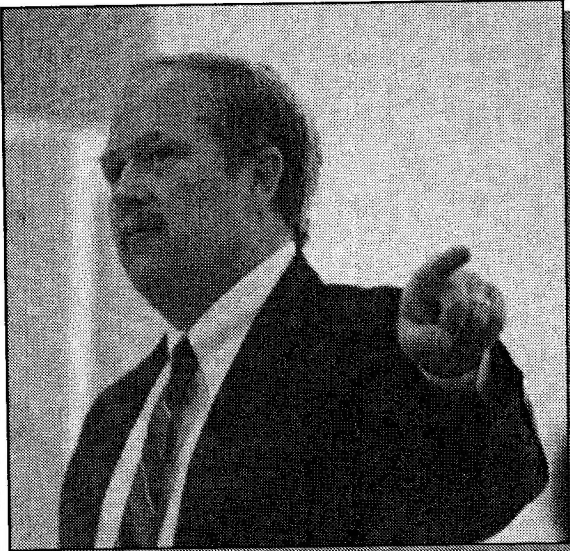
The Reverend Jesse Jackson will be speaking at “The Holy Land” on April 27, 2001. It's time to come out and stand for the truth, let your voice be heard.

Just when Sheriff Sills thought he had the Nuwaubians trapped in his web of confusion, the Reverend Jesse Jackson “ the peace maker” is coming to Putnam County on April 27, 2001 at 2:00 P.M., to get a first hand look at just what the corrupt officials are doing. With him comes worldwide media and the truth will finally have a chance to reveal itself. The truth being how the nine new land owners and the Pastor Marshall Chance of Holy Tabernacle Ministry located at 404 Shady Dale Rd. property “ **The Holy Land**” has tried relentlessly to settle all disputes about the property. They went before the former Chief Building Inspector Jerome “Dizzy” Adams in attempts to obtain permits for their property. In particularly the controversial “*Rameses II Social Club*”. In accordance to the United States Constitution, they have the rights as property owners to use the building. All the Judges know this. That's why in the court order against the former land owner (98-CV-136-5) it states that the former land owner could use the building , and we quote “ *if the defendants change the intended use of the said building and such use is done in a manner so as to legally comply with the zoning and building ordinances of Putnam County, then the defendants may use the said building for this purpose*”

This case (98-CV-136-5) started 1998 A.D. personally by Sheriff Sills, not the Building and Zoning Inspector, not the Board of Commissioner— **by Sills!** And it was against the former property owner, which has absolutely nothing to do with the new property owners or The Holy Tabernacle Ministry, but Sills wants to blame them because they are also black . He is trying to hold the new land owners under the old owner's court order. Taking away their rights to use the building for their intended purpose. Is it legal ? No, for 3 years Sills and Ford have been violating the property owners rights! They have done everything in their power to stop all construction on the 404 Shady Dale Property by keep everything in a state of mass confusion. **From fining a member of the Holy Tabernacle Ministry, Mr. Victor Greig, \$ 45,750.00, to illegal property searches, and banishment of another member of The Holy Tabernacle Ministry, Mr. Thomas Chism, preventing him from attending his church for 3 years..** What amazes us the most is when you check the county records on *Putnam County Ordinance Violations* you will find records that will reflect other Putnam County Residents as being fined for some of the exact same violations that Nuwaubian, Mr. Victor Greig was cited for. As you can see to your left on the next page. Why wasn't Mr. Robert Taylor , Phil Bailey and Leonard Lizek all fined thousands of dollars and dragged through the courts, then jailed ? Check the files they all committed the same crime that Nuwaubian Mr. Victor Grieg was accused of. This is further concrete proof of Sheriff Sills targeting the Nuwaubi-

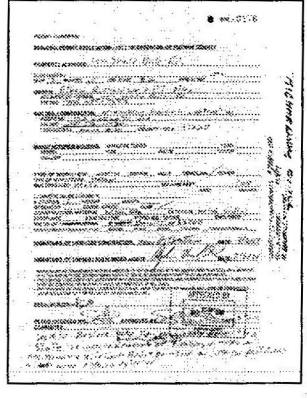
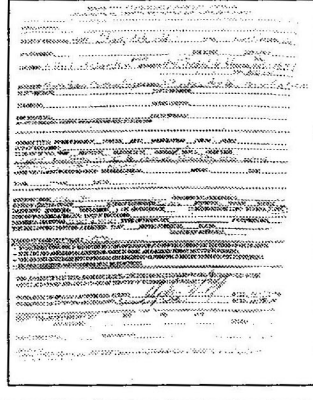
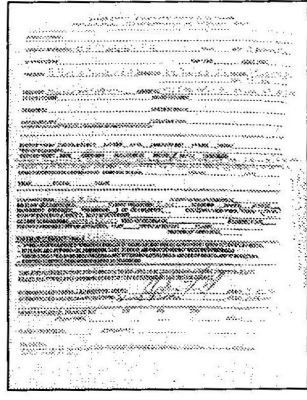
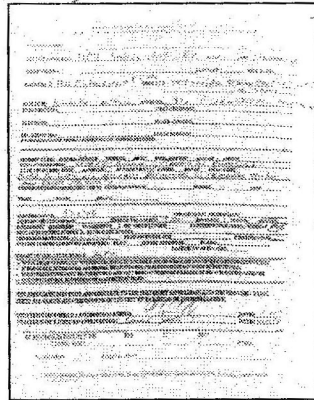
all blacks who own that land responsible for pervious court actions, these are nine new owners, not the old one. How long is this going to be allowed to go on ? When the new land owner decide to sell their property will he hold the next property owner if their black under the (98-CV-136-5) case also. The 404 Shady Dale Rd property is The Holy Tabernacle Ministry, the church has nothing to do with Rameses II Social Club, but yet church members are being made to suffer. Simply because they know the person they bought the property from . Doesn't everyone know the person they bought their property from? This man must be insane to think what he is doing is lawful . He must be sick to threaten the new land owners using written statements like "*I nor others will be required to stop at the gate. In the event that such entrance is prohibited, impeded, or delayed, it will no longer be possible for Woodall (the nine property owners agent) to demonstrate compliance with the injunction and the appropriate ordinances and the permit will automatically become void.*" There is nowhere in the court order that these stipulations are stated nor does he have the power from any judge to demand it. Nor do the court order apply to the new land owners who are not listed as defendants. This is just another one of Sills plots to cause confusion and intimidation. He is digging a bigger grave for himself to fall into every day. Leaving a paper trail of proof of his corruption behind him that the Nuwaubians can use in Federal Court.



With the Rev. Jesse Jackson coming to Putnam County, it will make it hard for any Federal Court Judge to just sweep this corruption under the table. For years now the Nuwaubians have been waiting for the right time, preparing to launch a litigation Under 42 U.S.C. 1983 against them. Section 1983 authorizes courts to redress violations of "rights, privileges, or immunities secured by the Constitution and [federal] laws." Sills whole Corrupt Klan , even the Judges are subjected to Federal Court. Just as you see Nuwaubians marching in the picture to your right, if this corruption don't stop, they will also be marching on the streets of Putnam on June 2, 2001 during the annual Dairy Festival passing out flyers , video tapes , audio recording and books revealing Putnam County's Corruption ! 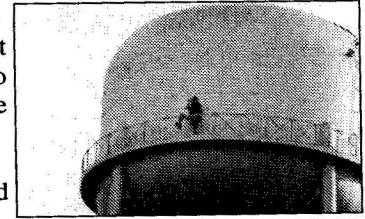
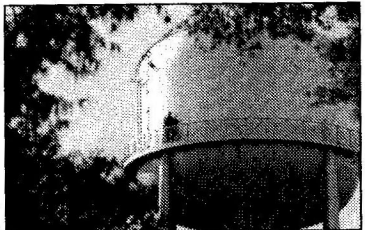
The last permit applied for dated March 6, 2001. This one was approved March 7, 2001 then stopped by Sills.

mus which is "commanding the performance of a particular act therein specified, and belonging to his or their public, official, or ministerial duty, or to his or their public, official, or ministerial duty, or directing the restoration of the complainant to rights or privileges of which he has been illegally deprived" The nine landowners stated in their case ... (9) Nevertheless, defendant Adams refused to issue a permit. Said refusal was appealed to defendant Putnam County who upheld the refusal to issue such permit. (11) Plaintiffs have exhausted all available administrative remedies. (12) Plaintiffs had a clear right to have a permit issued so they could use the building as a hunting club, pursuant to Section 4.3(1) .lf (2). (13) Nevertheless, defendants have failed to perform their official duties and allow the granting of the permit..

On October 11, 2000 in the last hearing about the case, The Honorable Judge Wingfield instructed the Nine New Landowners to apply for the demolition permit again and once they received it, Sheriff Sills was to remove the locks so the work could begin. Sound easy and fair right? Wrong, Ford and Sills made sure the permit was never given, stating to the new land owners that "their choice of words were wrong", rewrite it. The Agent in good faith rewrote it five times and still no permit, some of these permit applications are shown above. Sills seems to feel once the attention is off of the Nuwaubians, then his life will be in danger. Which is probably true, no one can speak for all the angry members out there. And his time is almost up. He as been hiding behind his badge in office for 1,622 days and has only 1,298 days to go. He will not get his seat again, if he can make it until the end. Look at what is happening in Cincinnati, with the shooting of Timothy Thomas a black kid who was shot in the back by a white officer. The riots that are taking place there could very well take place in Putnam County. People are tired of corrupt officers and they see no other way out. Sheriff Sills is afraid he will be hunted just as he had the Nuwaubians hunted during a rally in Putnam when the Nuwaubians brought in Rainbow Push Coalition, G.A.B. E.O., Able Mable, NAACP and others to the Court house steps. Sills literally had a sniper on the water tower as seen in the picture to your right. He is holding on to the Rameses II Social Club court case "FOR DEAR LIFE". In the meanwhile he is trying to incite a confrontation, as you can see, But his attempts of an assassination were ended when the Nuwaubians spotted this man and turned around and waved at him. It was all caught on video tape. It seems Sills thinks he can get away with murder! Maybe again like the motor biker, Michael Flynn a boy friend of his ex-wife Kathy Sill, who was found killed behind a black club in Putnam called the Tom Cat. We know who did it.

All of these injustices will be dealt with and documents will be released for your review. While Putnam County corrupt officials were doing their devilishment, the Nuwaubians were meeting with the TOP Officials and Civil Rights Activist in Georgia as well as Washington D.C, on how to get justice while bringing all matters to a peaceful end. Sheriff Sills slander, unstable and provoking actions makes the Nuwaubians fearful for their lives and now many want to strike back at him and his. The Nuwaubians learned quickly that the courts of the Ocmuglee Circuit served as no protection for them. And the more they tried to reach out to the people of Putnam County, the more Sills would lie and slander to keep the division.

On March 6, 2001, the Nine New landowners tried to obtain the permit again once the crooked Chief Building Inspector Jerome "DIZZY" Adams was out of office. Which was approved the very next day March 7, 2000 by the New Chief Building Inspector Mr. Robert Howell, PE as seen on the pervious page. And again Sheriff Sills blocked them with his March 14, 2001 letter of confusion. He wrote in hopes to confuse and intimidate the new inspector. The letter he wrote was a deceitful trick telling Mr. Robert Howell, PE the new land owners would have to agree to his new letter (which is full of threats) before he could give them their permit. What does his new letter have to do with the old land owner? What's wrong with this man- is he sick? He just can't hold

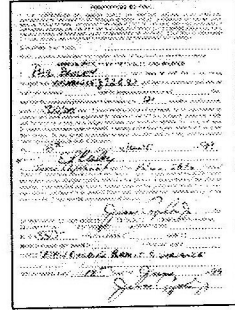
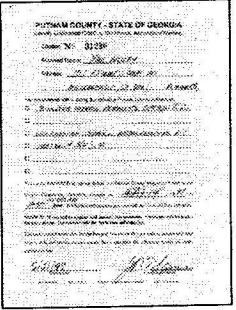


A sniper on the water tower located straight across from the court house. Placed their while the Nuwaubians were rallying on June 24, 2000

ans. He used the Former Chief Building Inspector Jerome "DIZZY" Adams as a pawn to help him, holding the fact that his daughter Julie Harper was convicted for "theft by taking" stealing \$ 10,824.66 from City Hall, **your money and did not go to jail!** and his son Jerome Dean Adams Jr. who was convicted of Burglary , DUI and was in violation of the controlled substance act. Sills holds this information over him because everyone knows, "the apple doesn't fall far from the tree". At least, that is how it seems the Planning and Zoning board referred to it , when they denied the nine new land owners the right to use their property on Dec 7, 1999 A.D. The nine new land owners sent their own agent, Mr. Al Woodall, to the board meeting to speak on their behalf in good faith, and he was met with complete opposition. Board members that served on that board for 5 to 10 years denied their request saying to them the court order was "too confusing" And that's the same excuse the Board of Commissioners used when they denied the nine new land owners their rights to use their property as well.

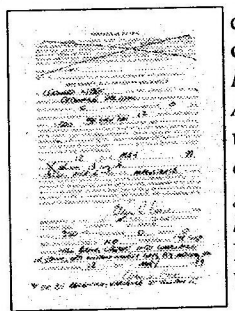
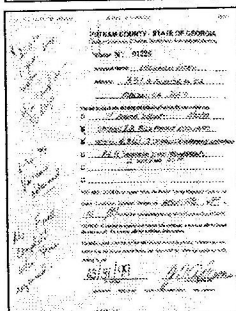
On February 24, 1999 Robert Taylor & DBA Economy Builders violated Code section 7.2, 7.3, 7.5. Fined \$1,000

Mr. Al Woodall went before the Planning and Zoning Board and the Board of Commissioners *with a plan that was in compliance* with the previous land owner court action, even though that court order did not apply to them . They proposed for Rameses II Social Club to be changed, to be used as a Hunting Club, in which their intention was to do all the necessary demolition and construction needed to convert it. The Court order clearly states (c) ***if the defendants change the intended use of the said building and such use its done in a manner so as to legally comply with the zoning and building ordinance of Putnam County, then the defendants may use the said building for this purpose***". This new use (The Hunting Club) is allowed and can be found *listed in the Putnam County Zoning ordinance Page 23 (Uses allowed in Agricultural District)..But the first step is to obtain the permit* before starting the work to bring it into compliance. As stated in the *Putnam County Zoning ordinance Page 131 Section 7.2 Building permit required*. He just can't stand the thought of blacks having a Hunting Club. Why? Because his theory of the new property owners stockpiling weapons goes out the window!

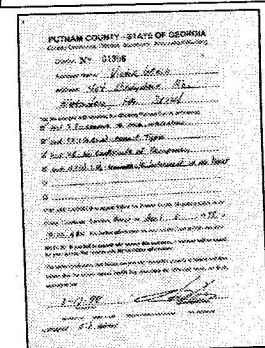


On June 16, 1999 Phil Bailey violated Code Section 7.2, R1, and 4.3(2).2. Fined \$ 350.00

This is evident from the fact that when Mr. Wesley Snipes the movie star was looking into purchasing the property at 290 Shady Dale Rd., with the intentions of training security guards which requires storing guns. Sills said in the **August 4, 2000 A.D.** Board of Commissioner Minutes we quote " *Sheriff Sills said he never had any discussion with Mr. Bishop whatsoever of what color these people were (black businessman, black or African American race four times in one paragraph). He told Mr. Bishop that if this was associated with the Nuwaubians that he would do what he could to stop it because the only places he knew on Shady dale Road to have a guard shack with an armed guard at the gate was the neighbor down the road on the adjoining property that he had to go to on several occasions with court order.*" Court orders that Sills created! He lied, trying to give the impression that he did not know that Actor Wesley Snipes is a black man. You can ask 10 people from all parts of the world what color Actor Wesley Snipes is. And they will all say black. These are the deceitful games he plays. He has racially targeted the Nuwaubians so much that now he fears the Nuwaubians having a club on their property where they can storage guns and sit around and talk about killing things all day for sport. So he paints the picture of Nuwaubians being terrorists to hide behind his fears, knowing it's all lies.



On April 28, 1999 Leonard Lizek violated Code Section 7.2, 4.3(2),2 and R-1 minimum yard requirements. Fined \$350.00- 1 year suspended upon compliance with in 90 days



All the officials (Sills friends) pretended that they could not comprehend the previous court order. Which clearly reads (c) ***if the defendants change the intended use of the said building and such use its done in a manner so as to legally comply with the zoning and building ordinance of Putnam County, then the defendants may use the said building for this purpose***"...Take note that the current property owners are not apart of this court order. However, because the nine new property owners rights were violated concerning the building they took the two boards decisions to Superior Court, Civil Action No. 2000CV05-01 and 2000CV191-7 demanding a manda-
