## "Deputies Of Putnam County Sheriff's Department Under Fire!"

In **SHERIFF HOWARD RICHARD SILLS'** Latest Ploy, He Is Trying To Use Psychology By Saying In *The Eatonton Messenger*, Dated **February 11, 1999 A.D.** On Page 6A **"THE CONNECTION** Between The Plaintiff And The Organization Can Be Found In Pamphlets Written And Distributed By The Concerned Citizens Of Eatonton And People Against Violence In Eatonton".

This Article Speaks About A Case Involving **MS. SHARON ANN HARRIS**, Who Is 29 Years Old And Born, In Eatonton, Georgia, On **July 7, 1969 A.D.** She Also Attended Morris Brown College, In Atlanta Georgia, Majoring In Therapeutic Recreation And Graduated In **1995 A.D.** **MRS. SHARON ANN HARRIS WAS NOT AND HAS NEVER BEEN A MEMBER OF THE NUWAUBIANS, AND STILL IS NOT TO THIS DAY.** So This Is Another Trick That **SHERIFF HOWARD RICHARD SILLS** Is Trying, To Make The Organizations, Look Like They Are A Part Or Party To **MS. SHARON ANN HARRIS'** Alleged Crimes; But His Trick Will Not Work. And Let Us Show You Why. **MS. SHARON HARRIS** Was Born And Raised Down Here, She Is Indigenous To This County. **MS. SHARON ANN HARRIS** Did Not Come Down Here With The Nuwaubians, Nor Is She A Part Of The Nuwaubians. **MS. SHARON ANN HARRIS'S** Case With The Putnam County Sheriff's Department, Started Back As Far As **October 16, 1995 A.D.**, With The Case **THE STATE VS. SHARON HARRIS 95CR158-9.** This Was Long Before **SHERIFF HOWARD RICHARD SILLS** Had A Run In With The Nuwaubians, And The Case In Question Is Civil Action No. **99CV30-2. MS. SHARON HARRIS**, The Plaintiff Vs. **NOELL LEE WILSON** And **CHARLES E. MYERS.** So, This Time The Crime Was Not Committed By **MS. SHARON ANN HARRIS**, But This Time The Alleged Crime Was Committed By **SHERIFF HOWARD RICHARD SILLS'** Highest Officers, **CAPTAIN CHARLES E. MYERS** And **DETECTIVE NOELL LEE WILSON** Who Are Under The Command Of **SHERIFF HOWARD RICHARD SILLS.** This Is Why He Should Be Concerned, Because Subordinates Are Under His Command. That Is Saying These Officers Are Under **SHERIFF HOWARD RICHARD SILLS**, Thus Making Him Their Superior Officer, Which Would Involve Him. (*Case Law Ford V. Byrd F.2D 194 (5th Cir. 1976)*) So Without The Tricks, Let's Deal With The Facts. This Alleged Crime Was Committed By These Two Officers, **DETECTIVE NOELL LEE WILSON** And **CAPTAIN CHARLES E. MYERS** Who Are Accused Of Stealing The Sum Of **\$6,944** Dollars. According To **CIVIL ACTION 99CV30-2**, This Is A Violation Of **Georgia State Code O.C.G.A. 16-8-2** Under Section Title **Theft By Taking "A Person Commits The Offense Of Theft By Taking When He Unlawfully Takes Or, Being In Lawful Possession Thereof, Unlawful Appropriates Any Property Of Another With The Intention Of Depriving Him Of The Property, Regardless Of The Manner In Which The Property Is Taken Or Appropriated."**

**MS. SHARON ANN HARRIS** Has The Receipts To Prove That It Was Not A Part Of Any Illegal Money, But Her Personal Money. So To Steal From A Criminal, Is Still Stealing, And Still Makes You A Thief, And With That, Makes You A Criminal. On Friday, **February 5, 1999 A.D.** **MR. MARTIN L. FIERMAN ESQUIRE ATTORNEY AT LAW**, Filed A Suit Against These Officers Individually As He Says In The Article *"Putnam Deputies Named In Civil Suit"* Page 6A And We Quote: *"I'm*

*Not Sure They Were Acting In Their Official Capacity, Fierman Said. 'The Accusation Harris Has Made Is Inconsistent As Their Roles As Law Enforcement Officers,' He Explained. "I Don't Believe They Were Acting Within The Scope As Deputy Sheriff's ..."*

If These Officers Committed These Acts While On Duty Or Clocked Time Then They Committed These Crimes As Officers Of The Law Which Makes Them Twice As Guilty As The Normal.

Shouldn't His First Reaction Be To Be On The Side Of The Law? Is That Not What He Is Being Paid For Unless, As The Nuwaubians Have Been Saying All The While, These Are Members Of The Pack.

Whether **MS. SHARON ANN HARRIS** Committed A Crime At This Point Or Not, Is Not Our Concern. The Point Is, These Officers, **DETECTIVE NOELL LEE WILSON** And **CAPTAIN CHARLES E. MYERS**, Who Have Sworn To Uphold The Law, Committed A Crime. How Can We Trust Them Or Feel Safe In Their Hands, If They Are Criminals. We Can't Trust Anything They Say.

And Then To Try And Deceive The People Of Putnam County And Seize The Opportunity Is In Itself In Bad Character. Look Here At How **SHERIFF HOWARD RICHARD SILLS**, In The Same Article, Is Trying To Tie The Nuwaubians In With Her Alleged Illegal Activities Before This Suit, And The Nuwaubians Only Had Dealings With Her Pertaining To The Upcoming' Suit. She Wanted To Make Sure The People Of Eatonton Heard Her Side Before, She Goes Into A Controlled Court Room With The Plotters, Who All Work Together. **MS. SHARON ANN HARRIS** Knows, She Would Not, Have A Chance At A Fair Trial. So, Before The Trial This Woman Was So Afraid Of These People That She Moved Out Of Eatonton, The Town Where Her Family Was Born And Raised (Her Mother Even Died Here), Because She Feared For Her Life. No One Should Have To Live Like That Especially In Fear, Of The Very People, Who Are There To Protect You Against, Criminals. And She Has Much More To Her Story, That Involved Officers From The Putnam County Sheriff Department, Such As **OFFICER DAVID GUNTER** Who Reached Into Her Underwear, As She Stated On A Notarized Signed Document, Which Will Also Be Made Public. This Looks Like Sexual Harassment. If This Is True.

Now, **SHERIFF HOWARD RICHARD SILLS**, Makes A Point To Bring Out A Connection, As He Called It With The Concerned Citizens Of Eatonton And People Against Violence In Eatonton. He Intentionally Avoids A Very Important Incident Recorded In The Appearance Bond Dated 4/14/ 95 You Will See The Signature, On The Appearance Bond For **MS. SHARON ANN HARRIS**, And You Will See, Also **MR. JIMMY DAVIS** Who Is On The **PUTNAM COUNTY BOARD OF COUNTY COMMISSIONERS**. This Bond Says That Both **MS. SHARON ANN HARRIS** And **MR. JIMMY DAVIS** And We Quote: *State Of Georgia Putnam County. Know All Men By These Presentations, That We, Sharon Harris As Principal Jimmy Davis Security Agree And Severally To Pay The Governor Of Georgia And His Successorts In Office Seventy-Five Hundred (\$7500.00) Dollars And For The True Payment Of Which We Bind Ourselves By These Presentments."*

The Question Is To Be Asked Of **SHERIFF HOWARD RICHARD SILLS** Is There A Connection Between **MR. JIMMY DAVIS** and **MS. SHARON ANN HARRIS**? And If There, Is **SHERIFF HOWARD RICHARD SILLS**, In Your Opinion, Why Didn't You Mention That To **MR. ROB PEECHER**, In The Article "Putnam Deputies Named In Civil Suit" In Which You So Loosely Mentioned A

*assigned shall have exclusive control of such action, except as provided in these rules, and no person shall change any assignment except by order of the judge affected and as provided in these rules. Why Is It That In The Whole Sheriff's Department Of Putnam County, 2 Officers Get Accused Of A Crime And Mr. Ford (Who Should Have Nothing To Do With This) And Mr. Sills (Who Should Have Nothing To Do With It) Have Something To Say. And There Is Not One Single Quote In The Entire Article From **DETECTIVE NOELL LEE WILSON**, And **CAPTAIN CHARLES E. MYERS**. We Repeat, There Is Not One Quote From Them. Yet, We Have Multiple Quotes From **SHERIFF HOWARD RICHARD SILLS** And **ATTORNEY FRANCIS NEARN FORD**. A Blind Man Can See This.
