

Does The Zoning Ordinance Of 1997 A.D. State A Video Camera Can Be Used While Inspecting?

No, Yet And Still Every Time The Chief Building Inspector **Mr. Jerome Dean Adams Sr.** And **Sheriff Howard Richard Sills** Go Out To The 404 Shadydale Property They Always Bring A Video Camera, As If They Are Not Breaking The Law. But They Do Not Video Sheriff Sills' Actions. We Videotape So You Can See Them Violating Our Rights. Internationally Recognized Organizations Have Investigated And Acknowledged The Fact That Our Religious And Civil Rights Are Being Violated. **Mr. Joe Beasley**, The Southern Regional Director Of The **Rainbow/PUSH Coalition** (Founded By An American Hero, Reverend Jesse Jackson) Confirmed That The Harassment And Targeting By Sheriff Sills Was True When He Made A Press Release Stating That Our Claims Were "**Valid And With Merit.**" NAACP Also Became Concerned With The Harassment And Targeting. The NAACP National Field Director **Mr. Nelson B. Rivers** Met With **Holy Tabernacle Ministries, Inc. Pastor Marshall Chance** And **National Spokeswoman Mrs. Renee McDade**. After A Thorough Investigation Of The Sheriff Department, He Too Came To The Conclusion This Entire Situation Is **Racially Motivated** And Is Getting Out Of Hand Because All Of This Started Out As Merely False Zoning Violations. **Rev. Alexander Smith** Of The **Augusta NAACP Branch**, **Pastor Omar Reid**, **Rev. Tony Fraley** And **Rev. Macklin** Of The **Milledgeville NAACP Branch**, **Mr. Ronald James** Of The **Monticello NAACP Branch** Have All Come To The Aid Of The Yamassee Native Americans Moors Of The Yamacraw Nation (Nuwaubians) And Thousands Of Letters Are Being Sent From All Over The World To Government Officials Letting Them Know What Is Going On In Putnam County. **State Representative Tyrone Brooks** Visited Tama-Re, Talked To The Holy Tabernacle Ministries Inc. **Pastor And Reverend Malachi York** Of The International Egyptian Church And He Is In The Fight. **Governor Roy Barnes** Personally Met With **Mr. Malachi York's Attorney, Former State Senator Leroy R. Johnson** About Putnam County Officials Targeting Our Church. The Meeting Was A Success And Thus More Investigations Are On The Way. And All Of Those Who Let This Get Out Of Control And Sheriff, Get Away With All Of This, Will Fall With Him.

The Building Inspector Should Be Well Aware Of His Duties And Especially The Laws Involving His Profession Right? So, Why Is It That On These Supposed Inspections There Is Always A Video Camera? No Where In The **Putnam County Zoning And Ordinance Book Of 1997** Does It Mention Anything About The Right Or Law To Bring A Video Camera To Be Used During Inspection No Where! Read It For Yourself On Page 129, **Section 7.0 Under (C) Inspections States:**

"To Make Field Inspections To Determine That The Building, Construction Or Structural Alteration Or Use Is Being Pursued In Accordance With The Site Plan For Which A Development Or Building Permit Has Been Issued And In Compliance With This Ordinance. These Inspections And Reports Of Findings Shall Be Made As Soon As Practicable After Inspection Is Requested By The Developer. When A Violation Is Found To Exist, The Building Inspector Shall Immediately Advise The Chairman Of The Board Of Commissioners Of The Violation So That Appropriate Legal Action May Be Taken To Ensure Compliance."

Now **Mr. Jerome Dean Adams Sr.** May Try To Say He Is Not Videotaping, But That's Not Good Enough Because You, **Mr. Jerome Dean Adams**, Did Not Take Charge Of This Situation And Inform **Mr. Sills** And Which Ever Deputy "**From His Good Ole Boy Gang**" He Choses To Bring, That By Law, They Can Not Bring A Video Camera To Videotape Private Property. Especially Now Since The Only Reason **Mr. Sills** Went Out To The **404 Shadydale Property** Is Supposedly To Accompany **Mr. Jerome Dean Adams Sr.**, Not Supersede Him Which He Does Everytime. Since This Is Supposed To Be A Legal Inspection, And Not A Search Warrant. **Mr. Sills** Falls Under **Mr. Jerome Dean Adams Sr.** Authority And Not The Other Way Around. But If You See Them, Sheriff Sills Treats Him Like A Pet, Telling **Mr. Adams** What To Do And Even Yelling And Pointing. It Is Sad. In Other Words **Mr. Jerome "Dizzy" Adams** Should Take The Lead In The Inspection Right And **Mr. Sills "Accompany"** Him By Law. This Is Never The Case, And We Have The Videotapes To Prove It. So As Usual **Mr. Sills** Does What He Wants Above And Beyond The Law, Past His Official Capacity And Is Using **Mr. Jerome Dean Adams** In A Deceptive Way To

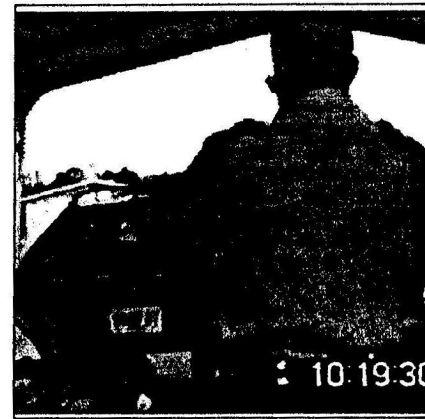
Illegally Videotape For His Own Diabolical Schemes And Secret On Going Investigation. Here **Detective Harper** Is Seen Recording The License Plates Of People's Cars Which Will Probably End Up On New False Charges. What Does This Have To Do With A Building Inspection? In A Nut Shell **Mr. Sills' Basic Attitude Is He Going To Bring Someone To Videotape Because That's What He Wants Even though It Is Against The Law.** In An Article Entitled **Police Open To Lawsuits Over Media Ride-Alongs'**, Shows A Supreme Court Decision, In The Case **Hanlon Vs. Berger 97-1997** Ruled Against Filming During Raids And Searches, And Was Upheld In An 8 To 1 Vote Previously, By An Unanimous Decision Was Approved. In The 9th U.S. Circuit Court Of Appeals Ruled That **Mr. & Mrs. Berger** (Whose Privacy Was Violated), Could Sue The Government Officials Involved In A Raid As Well As CNN. **Chief Justice William H. Rehnquist Wrote For The Nation's Highest Court And We Quote: "It Is A Violation Of The Fourth Amendment For Police To Bring Members Of The Media Or Other Third Parties Into A Home During The Execution Of A Warrant When The Presence Of The Third Parties In The Home Was Not In Aid Of The Execution Of The Warrant"**. In Other Words, It Is Against The Law To Bring Another Party In Something, When They Have Nothing To Do With What Is Written On The Official Document. This Is The Same Violation Whether It Is Done By The Media Or A Person Holding A Video Camera. Even If **Mr. Sills** Said He's Recording For Records Of His Actions. That Is Not True. The Shots We Show You, His Deputy Who Is Holding The Camera Is Always Pointing Away From Him. At Other Parts Of The Land Or People, Private Property Or Cars Coming In And Out Getting License Plates For Future Evil Plans. So That Is Not A Good Enough Excuse, For Breaking This Law. This Is Along The Same Lines Of What **Sheriff Howard Richard Sills** Did On The **Tyrant Adolf Hitler's Birthday, April 20, 1999 A.D.** The Same Day **General Lee** Surrendered And The War Was Over, A Confederate Hmmm. The Court Order Specifically States For The **Building Inspector To Inspect** With An Option **Sheriff Sills To Accompany Him**. According To The **April 13, 1999 A.D.**, Court Order Signed By **Judge Hugh V. Wingfield**, "*...The Putnam County Building Inspector Shall Have Free Access To The Property...At His Sole Discretion, The Building Inspector May Elect To Be Accompanied By The Sheriff.*" **Mr. Sills** Took It Upon Himself To Bring **Detective Noell Lee Wilson**, A Third Party And Instructed Him To Videotape. All Of It Was Illegal And Legal Action Has Been Taken. This Is A Direct Violation Of The 4th Amendment Which States: **Searches And Seizures Prohibits Unreasonable Searches And Seizures Of Persons Property (To Protect Privacy)** Also On **May 6, 1998 A.D.** **Mr. Sills** And His Entourage Of 17 Squad Cars And K-9 Unit, Arrived To Change 6 Locks On 6 Already Locked Doors, Arrived At The 404 Shadydale Property. He Also Brought His Own Camera Crew To Film His Moment Of Glory. **Mr. Sills** Had No Right To Invite Any News Reporters And **Ms. Jena Frazier** From **The Union Recorder**, To That Private Property Without Getting Permission From The Owner. Once The Media Made It To The Property They Were Told They Could Not Proceed. They Wanted To See What Sheriff Sills Said.

Who Gave **Mr. Howard Richard Sills** The Right To Have His **Detective Noell Lee Wilson** Bring A Camera Or Video Recorder On Private Property To Intrude On The Privacy Of The People Who Live There? Well, According **O.C.G.A. 16-11-62** They Are Breaking The Law And Have Illegally Videotaped On Private Property Without The Consent Of The Owner Or Owners Nor The Residents And Have Done So On Several Occasions. Just Because **Mr. Sills** Has A Badge And A Gun Does Not Mean He Has The Right To Break The Law. **O.C.G.A. 16-11-62** States: "*It Shall Be Unlawful For: (2) Person, Through The Use Of Any Instrument Or Apparatus, Without The Consent Of All Persons Observed, To Observe, Photograph, Or Record The Activities Of Another Which Occur In Any Private Place And Out Of The Public View; (3) Any Person To Go Or About The Premises Of Another Or Any Private Place For The Purpose Of Eavesdropping Upon Their Conversations Or Secretly Observing Their Activities.*"

From The First Time **Mr. Sills** Brought His Deputy And Buddy From **Balwin County** To Tape, They Were Informed Over And Over That They Were Taping Without Permission. Infact, They Were Told Directly That They Did Not Have Permission By Chief Security Officer **Claude Turner** Of **M.I.B./Max International Inc. License No. 905**, On **January 12, 1999 A.D.** And Were Made Well Aware Of This Violation Of Private Rights, Yet And Still They, **Deputy Noell Lee Wilson** And Even **Sheriff Howard Richard Sills** Himself At One Point Took The Video Camera And **Began Recording** And Continued This Illegal Action, Which Is Also A Violation Of Privacy Because This Is A Private Place. According To **O.C.G.A. 16-11-60** Private Place Under (3) Is: "*A Place Where In Is Entitled Reasonably To Expect To Be Safe From Casual Or Hostile Intrusion Or Surveillance.*" Then On **May 26, 1999 A.D.** A Mysterious Person Pulled Up In Front Of The Entrance And Videotaping. Again This Shows Sheriff Sills' Total Disregard For The Laws When It Pertains Or Goes Against Something He Wants. The Problem Is **Mr. Sills** Has Too Many Arms In Too Many Things. Someone Has Given Him Too Much Power And He Is Still Trying To Get More. He Needs To Be Put Back In His Place And His Power And Position Removed Since He Has A Lack Of Respect For The Laws He Is Supposed To Uphold. **IN GOD WE TRUST!**
