And According To The Georgia Department Of Human Resources, Vital Records Unit Marriage License From Putnam County, Francis N. Ford And Dorothy J. Adams Were Married On April 11, 1998 And A License Was Given Under The Hand And Seal Of Pauline S. Carter, Clerk Of The Probate Judge. But You Know What? This License Was Issued And Signed In Their Ordinary Fashion, They Are Not Legally Married, Because Under State File No. "?? (Wait A Minute, There Is No File No.) In The Upper Right Hand Corner, There Is No Number Listed, Nor A County Number. They Did Not Legally Register This License With The State. Everything About What He Does Always Has A Tilt To The Left. Immediately After, Mrs. Helen Carnes, Putnam County Clerk, Was Called And Asked, "Is Dorothy Jean Adams The County Attorney?" In That Order, She Was Asked: Is Dorothy - Jean - Adams The County Attorney. She Knew Right Away Who The Caller Was Talking About. And Helen Carnes Responded, "Yes." Then Jimmy Davis, Who Is One Of The Five Commissioners That Appointed Dorothy Adams As The County Attorney Was Asked, "Has Dorothy Jean Adams Been Fired As The County Attorney Because Frank Ford Claims That She's Not." In That Same Order, Dorothy - Jean - Adams. And Jimmy Davis Responded, "No She Hasn't Been Fired And As Far As I Know, She Is Still The County Attorney." He Had No Problem With Associating The Middle Name Jean With Who He'd Been Knowing For Years As Dorothy J. Adams. Then, On March 14, 2000 A.D., Marianne Tanner Was Called And Her Conversation Went As Follows:

- Caller: Hello, Can I Speak To Mrs. Tanner?
- Tanner: This Is She
- Caller: Hello, Mrs. Tanner, I'm Sorry For Calling So Late, I'm With Attorney Ralph Goldberg's Office, And I'm Calling To Confirm Our Records.
- Tanner: O.K.
- Caller: I Would Like To Know If You Will Be At The Deposition Tomorrow?
- Tanner: Yes, I Will
- Caller: Are You Coming Alone Or Are You Going To Be Represented By An Attorney?
- Tanner: By Attorney

And Distinguishing That Person Or Thing From Others."

Most Of The Time Legal Applications Ask For Your First And Last Name And Usually Only Your Middle Initial, Which Shows That Your Middle Name Is Not As Important As Your First And Last. For Example The Social Security Card Might Have A Middle Name On It, Or It May Not. Sometimes It Might Even Just Have The Middle Name Initial, Or The Sr. (For Senior) Or Jr. (For Junior) Is Missing. Other Legal Documents, Even Ask For Your Nickname Or

The Name You Go By. We Have Court Transcripts Naming The Building Inspector As Jerome "Dizzy" Adams. Dizzy Is Also Within His Name In Numerous Newspaper Articles, But We Want To See His Drivers License, His Passport, Or Credit Card With "Dizzy" On It. His Legal Name Is Jerome "Dean" Adams Sr., So If Sr. Is Missing From His Name, Does That Mean He Is Not The Building Inspector And That He's Really His Son? And That Would Mean That He Would Be The Convicted Felon And Not Eligible To Hold That Position. And His Own Official Letterhead Has The Name J.D. Adams And Under It, Is The Title Chief Building Inspector. There Is No Sr., Jerome Or Dean Confirmed, So How Do We Know That This Is Mr. Jerome Dean Adams Sr. With All Of These Abbreviations And No Sr. Or Jerome Dean? Well, Mr. Ford, Simply Because We Know Him. And Everybody In Court Knows That In Court And On The Minutes They Refer To Him As "Dizzy" And That's Not His Legal Name. 
