Why Would Judge Hugh V. 3. Going To Different News Stations Just To Get A Story, And Then Making Statements In News Articles Such As "*Now You Tell Me What A Piece Of Property With Armed Guards At The Gate, With An Individual Who Proclaims To Be God In The Flesh Who Openly Proclaims That A Spaceship Will Be Arriving To Take 144,000 People Away To The Planet Rizq Is I Ask You, Is That Not A Cult*" He Said" As Found In The Coastal Empire Newspaper Article Entitled "*Georgia's Little Egypt*" Dated **Sunday August 16, 1998 A.D.** Now You Tell Me What Does A Persons Religious Belief Have To Do With Law Enforcement, And Fighting Crimes? Isn't This A Religious Issue? This Also Shows That He Disagrees With The Nuwaubians Religious Beliefs As Yamassee Native Americans, Called Nuwaubu. This Is Religious Persecution And Again This Shows Personal Interest.
