**WHAT IS SHERIFF HOWARD RICHARD SILLS**  
**DOING IN WESLEY SNIPES' BUSINESS?**

Sheriff Howard Richard Sills is at it again, harassing yet another Black businessman. As usual, he is sticking his nose where it doesn't belong and starting unnecessary trouble. And as usual, he is going to claim that he is just doing his job. For instance, on May 15, 1999 A.D., on **WMAZ Channel 13 Eyewitness News**, Sheriff Howard Richard Sills stated, *"I have never gone on that property when I did not go there pursuant to a court order, other than a few times we had calls there"*. This is just another example of Sheriff Howard Richard Sills knowingly and willfully lying. Listen to him contradict himself right in front of you. Maybe he does not know what the word 'never' means. He said and we quote, "I have never gone on that property....pursuant to a court order", which would imply that he would only go out there if a judge ordered him to. Then, in the same sentence and out of his own mouth, he tried to fool you by adding the words, 'other than'. Either you never did it, or you did do it. This is what we mean when we say he has a blatant disrespect for other people's intelligence. He thinks he can say anything, and nobody is going to analyze the truthfulness of it. Now back to the point of lying.

Here's how we can prove in a court of law that he was making false statements. (1) He went to 404 Shady Dale Rd. on March 9, 1998 A.D., inquiring about alcohol sales, which he heard from a Mr. Doug Richards of Fox 5 News in Atlanta on an evening broadcast. This was not pursuant to a court order and not in response to any calls that were made to him. (2) Then he went to 404 Shady Dale Rd. on **March 17, 1998 A.D.** to issue 4 citations, no. 01306 to Mr. Victor Greig, without due notice, and he was not there pursuant to a court order, and it wasn't in response to any calls that were made to him. (3) The very next day, on March 18, 1998 A.D., in an attempt to further validate his allegations, Sheriff Howard Richard Sills called in state fire officials, District Supervisor For The State Fire Marshal Officer, **Mr. John Yearwood** and Fire Safety Compliance Officer, **Mr. Lewis Brown**, to inspect Rameses II Social Club. Again, **this was not pursuant to a court order or in response to any calls that had been made to him. THIS WAS PURE HARASSMENT!!!** Which the court date, April 8, 1998 A.D., proves, because **Mr. Lewis Brown stated on page 143 on the transcripts of the Putnam County, State of Georgia vs. Victor Greig.**

So now, let's watch carefully and see what Sheriff Howard Richard Sills makes up about Mr. Wesley Snipes. Tell us Sheriff Sills, what court ordered you into Mr. Snipes' business? And don't give us that "I'm just doing my job", because your job is not to harass hardworking, taxpaying, money making citizens with false accusations, trumped up charges and bogus lawsuits. Look at how he's already attempting to chase Mr. Snipes out of town.

According to the Macon Telegraph article entitled, **"Snipes' Company May Buy Property"** dated **February 18, 1999 A.D.**, Sills said: *"I had heard rumors about it, but I hadn't heard anything lately until yesterday, when I got a call from an inspector with the BATF,"* Sills said Tuesday. *"he was following up on the application for a federal firearms dealer license that the Royal Guard Of Amen-Ra, Inc., had applied for back in December."* First of all, Ray Charles can see that Sheriff Howard Richard Sills is lying about the Bureau of Alcohol Tobacco and Firearms (BATF) calling him. He would have added the name of the agent he spoke to. That's standard practice as a confirmation of what he said is true. We don't doubt that he spoke to the BATF, but it is more likely that Sheriff Howard Richard Sills called them; that's what he does. He initiates his own investigations based on what he sees on T.V. For instance, on March 3, 1998 A.D., Sheriff Sills saw a news report on Fox 5 in Atlanta with Doug Richards, who claimed that Rameses Social Club sold alcohol (which was not true). Two days later, on March 5, 1998 A.D. he wrote a letter to the commissioners asking them to give him the position of code enforcer so that he could have a legal right to go onto the private property at 404 Shady Dale Rd. to investigate the club. The resolution that made him the code enforcer came about in a two-minute meeting on March 6, 1998 A.D., and was done illegally as it was in violation of O.C.G.A. code 8-25-25 c) which states: *"That in order to enforce any local amendment, the local government must submit the proposed in the department of community for review. Sills going to let Mrs. Marianne Tanner be the fall guy or scapegoat, and maybe end up in prison or declare her insane and say she had a nervous break down to clear their hands? But it is very clear to everybody in court that they are running, because they have no case. And of course, their leader, Attorney Ford, is conveniently out of town, as these interrogatories are being sent out and they require some very intricate answers. So they are all panicking. And it all started with a racist sheriff messing with a Black organization with an Egyptian name in Putnam County.

Well now, Sheriff Howard Richard Sills is messing with Mr. Wesley Snipes, another Black man with a Black organization with an Egyptian name. Sheriff Howard Richard Sills stated that he had written a letter to the BATF on Tuesday, February 15, 1999 A.D., on which he noted inaccuracies on the Royal Guard application. If the BATF is involved, why does this little town sheriff have his nose in it? Anyway, Sheriff Sills stated:

1. ***"Snipes certified that he had provided Sills with a copy of the BATF application, which Sills said he had not"***. You really can't trust this because the officials in town are known for hiding paperwork and permits. For instance, a building permit application was found and retrieved from the Building And Zoning Office, which listed the use of Rameses Social Club as a 'social club'. This is the very same building permit application that they say Mr. Malachi York never had. Out of his own mouth on June 19, 1999 A.D. Sheriff Sills said, "many of the buildings were built without any permits whatsoever. They were just built without permits or had not received certificates of occupancy."
2. ***"Snipes stated that the property identified as 290 Shady Dale Rd., is owned by the Royal Guard Of Amen-Ra, but deeds indicate that S.M. Bishop Co., Inc., owns the property"***. Again, on the news it shows that he filed an application for license under #18 USC Chapter 44 Firearms, The Royal Guard Of Amen-Ra Inc. Under #5 business address, it states 290 Shady Dale Rd. Eatonton, GA 31024. On Channel 13 WMAZ, Frank Malloy on February 16, 2000 A.D. said, ***"We also obtained a copy of a federal firearms license application. The application is signed by Snipes and lists an address on Shady Dale Rd. in Putnam County."*** Now

again, the media is clearly stating that Amen-Ra owns the property already. Otherwise they would not have listed that address as far back as December. Sills and them are up to their stuff again by deceiving the towns' people by rushing to their media friends and changing the story around to get everybody confused. All of this because he's afraid of a Black business company. Not merely Wesley Snipes, because he is only one of the General Managers as Mr. Frank Malloy plainly said on that broadcast. Now this is outright racial profiling at it's highest. And all the Nuwaubians will be writing the Rainbow/PUSH Coalition, NAACP, SCLC and GABEO to name a few, in order to get everybody's attention on this right now.

3. ***"Snipes stated that the Royal Guard has obtained a business license to operate in Putnam County, but the county has not granted the company a license, according to Sills."*** First of all, it is not the county that grants business licenses. They have no authority to do so. So of course Sheriff Howard Richard Sills can say that no business license has been obtained for Putnam County, because a Putnam County business license does not exist.
4. ***"Snipes stated that the business has complied with state and local laws, but does not take into account that the property is zoned for agricultural purposes and "a for-profit security company and firearms dealer is certainly not an agricultural business"***. Hmmm, a slight case of de ja vu. Here we go again. These are the same exact words they used against Mr. York, 'zoning problems'. They are trying to start another long litigation and drain Putnam County out of more money while trying to block real money from coming into Putnam County. Simply because the hand that has that money is the hand of a Black man or woman. They couldn't wait for Ms. Alice Walker to get out of Putnam County. Again, Sheriff Howard Richard Sills is playing word games. He specifically uses

the words, "firearms dealer." However, the application submitted to the BATF from the Royal Guard of Amen-Ra does not say anything about selling weapons. According to the American heritage dictionary a dealer is "a person who sells goods". Sheriff Howard Richard Sills knows that it is not Mr. Snipes' intention to sell weapons, yet he puts this thought in the air so that the planning and zoning board and board of commissioners can have a right to deny Mr. Snipes' request to re-zone his 257 acre property. Again, this is the same trick they tried to pull over on the owner(s) of 404 Shady Dale Rd. They convinced the owner, Malachi York, to say that he wanted to build a theme park, which was never in his plans, just so that they would have a reason to say no to rezoning 19 acres of his 476 acre property.)

It is not hard to analyze and see the obvious pattern of harassment of Sheriff Howard Richard Sills. Just imagine what he is seeing is mind after all he's done to Black people. Let's say Stevie Wonder, as a Nuwaubian brings his money to Putnam County. And Jimmy Cliff brings his money to Putnam County. And Denzell Washington brings his money to Putnam County and Erykah Badu brings her money to Putnam County and Jermaine Dupree brings his money to Putnam county along with the money that Malachi Z. York has already brought to Putnam County. Don't you see the fear...Black hotels, Black resorts, Tiger Woods playing golf on a Black golf course, the creation of jobs, better health plans, homes for the Black elderly, building of new churches and temples, drawing in ethnics and white Nuwaubians from all over the world like they saw was happening with the annual gatherings increasing year by year on the property. This is a white man's especially a racist's worst nightmare. And these weren't ordinary Black folks coming in. Again we repeat, Nuwaubians are not just movie stars, producers, movie producers, recording artist and comedians, but doctors, scientists, judges, lawyers, F.B.I agents, correctional officers, policemen, sheriffs, firemen, principals, teachers, magicians, clowns, and the ordinary person off the street. The reason why they were so concerned with Nuwaubians conversion on college campuses, which contradicts their doctrine, is because the colleges are saturated with Nuwaubians, and not converts. They were born and raised Nuwaubians and trained to go to school to get a good education to make a change. They are Rainbow/PUSH, NAACP, SCLC, and GABEO members. That's the greatest fear of a racist whose prophecies failed. By that I mean, he claimed that the Nuwaubians would be standing around waiting for a flying saucer to come in the new millennium. Instead, Nuwaubians rented the largest hall in Athens, and had their annual Nuwaubian ball. He feared that Nuwaubians was a suicide cult like the Waco's as he called them. proposed amendment to DCA 60 days prior to proposed adoption of such amendment.” Sheriff Howard Richard Sills did not even fill out an application, turn in a resume or any other credentials that would prove that he has (1) knowledge of Putnam County ordinances or (2) detailed knowledge of specific ordinances that position has responsibility for enforcing. In fact, he openly admitted in the **Eatonton Messenger** on **March 12, 1998 A.D.** that his job will not mean checking construction sites to make sure certain buildings are within the county’s guidelines. Sheriff Howard Richard Sills did say and we quote: **“I WOULDN’T KNOW WHETHER THEY WERE OR NOT”**. This proves that he was not qualified for the position, yet you see him on countless flyers made available by the *Concerned Citizens Of Eatonton* and *People Against Violence In Eatonton*, where he is pictured acting the part of a building inspector and code enforcer. And all of these will be made available on videotape. The bottom line is that Sheriff Howard Richard Sills saw something that disturbed him on T.V., or what he thought was a “Black nightclub that sold alcohol” and he, playing “super-cop,” decided to do whatever it took to put a stop to it. Not the illegal sale of alcohol, which everybody knows is called bootlegging, and is all over the South, and up and down ‘The Strip’. But rather his friend, Francis Nearn Ford informed him that these people made \$75,000.00 in three month period, and he does not know any Blacks that have ever made that kind of money in only three months. This meant development and further progress. A wake up call to African-Americans; there is a place for them in Eatonton where they can socialize. This is what he wanted to stop.

Well, this is the same thing he is doing with Mr. Wesley Snipes. It wasn’t until he saw reports aired on WMAZ 13 and Fox 24, which spoke of Mr. Wesley Snipes’ plan to build a security-training center next door to the Nuwaubians. It bothered him when Mr. David Bailey of Fox 24 stated on February 17, 2000 A.D., that his own sources told him that Mr. Snipes is a Nubian/Nuwaubian. It also struck a nerve when he saw that Mr. Snipes had filed an application with the BATF and was going to get a legal federal firearms license to purchase, move, travel with, and store weapons and ammunition. The very next day, Mr. Rob Peecher did his friend, Sheriff Sills, a favor by claiming that earlier that week, Sheriff Sills had been contacted by the BATF. Now, just like how he quickly responded to the Nuwaubians, he probably got on the phone and initiated an investigation against Mr.

Snipes. I’m sure if we contact the BATF, or look at Sheriff Sills’ phone records, we will find out that he is the one who called the BATF first. What makes us think that? Well other than his consistent pattern of harassment, he also has a consistent pattern of mistakes and putting his foot in his mouth. He made a mistake and put his own foot in his mouth (as usual) when he said himself that an agent for Mr. Snipes had applied for the federal firearms license back in **December**. Now here it is **February**, and you mean to try to make us believe that the BATF is just now calling to follow up on his application? And it just happens to be within the same week that the Nuwaubians put a ‘For Sale’ sign up. All of this just happened to have happened within the same week. **Stop!!!** Who do you think you all are fooling? You can fool the citizens of Putnam County who support you, but we’re not buying this crap. This makes absolutely no sense, and the fact that it happened just a few days after the media broke the story of Snipes possibly being a Nuwaubian, makes it even more suspicious. And the fact of the matter is that we really can’t believe anything printed by the *Macon Telegraph*, because they purposely print Sheriff Howard Richard Sills’ lies. For instance, on May 12, 1999 A.D. the *Macon Telegraph* printed an article called **“Nuwaubian Charged With Falsifying**

**Documents”**. In it, they printed Sheriff Howard Richard Sills’ lie that said, “Sills said Lavender confirmed that he had been talking with Chism about bringing his circus to the 476-acre Nuwaubian village....” However, after speaking several times to Dr. James E. Lavender, who is the owner of the circus, he confirmed that he had never met, talked to, or corresponded with Mr. Thomas Chism and he is willing to testify to this fact in a court of law. In the Putnam County Superior Court on November 15, 1999 A.D. in front of the Honorable Judge James L. Cline Jr., Sheriff Howard Richard Sills is trying to get Mr. Chism to say he is guilty of something that he knows he did not commit. It is called ‘plea bargaining’; it is a way of saying, ‘I am guilty, but in a lesser way’. When they know that Mr. Chism is not guilty and that the forgery took place in the Building And Zoning Office or the office of Attorney Francis Nearn Ford. They have no case, which was verified again on February 21, 2000 A.D. in case #99ST-R-2-1, because the Honorable Judge Hulane George ordered a continuance until April 24, 2000 A.D. Why? Because Sheriff Howard Richard Sills did not make arrangements for Dr. James E. Lavender, the owner of the circus, to be in court. Because it has been proven beyond a shadow of a doubt that Marianne Tanner lied under oath. (Read flyer **“Did Marianne Tanner Lie Under Oath And Get The Boys Arrested?”**) And there is strong evidence to prove that Mr. Chism delivered an incomplete or unsigned document to her. Is Francis Nearn Ford and Sheriff Howard Richard
