**And The Saga Continues,** This Is Part 2 Of This On Going, Situation. Three Days After Mr. Adams Initial Visit, He Came Back But This Time Was Accompanied By **Mr. Sills** And **Detective Lee Wilson** (With A Camcorder To Videotape), On The Morning Of **October 26, 1998** Between The Time Of **10:30 A.M.** And **11:00 A.M.** When These 3 Men Entered The Pylon, Mr. Sills He Spoke To Mr. Chism Stating The Nature Of His Visit And We Quote:

**Sills:** *"I Am Here In My Official Capacity To Inspect That Foundation And To Take A Look At This Mobile Home And Make Inquiries As To How It Got On This Piece Of Property Without Being Permitted."*

**Chism:** *"It Is Permitted, I Have The Permit Right Here. The House Belongs To Dr. Kimbrough M.D. His House Was Moved From Over There Until He Was Able To Find Somewhere To Move It. I Explained That Before."*

Then **Mr. Sills, Mr. Adams** And **Detective Wilson** Drove Over To The Area In Question. The Following Is The Dialogue Between **Mr. Chism,** And **Mr. Sills,** While **Mr. Adams** Just Stood There. **Detective Wilson** Was Video Taping During All Of This. This Is What Took Place And We Quote:

**Sills:** Ok..... I Am Going To Lead On To My Next Question... Next Question Is Mobile Home, I See You've Taken Down The Fence, In The Court. Who Is In Charge Of That Building? Who?

**Chism:** Dr. Kimbrough.

**Sills:** Who Owns The Property That Building Is Sitting On?

**Chism:** Malachi Z. York.

**Sills:** Now.... Do You Have Any Control Over Or Management Over There?

**Chism:** Dr. Kimbrough Moved His House From Over Here.

Situation As Before, When Sheriff Sills Went Into His Own Pocket In A Violation Of O.C.G.A. 1-3-3 (7) To File An Injunction Without The Commissioners Support, Taking The Case Personally To Try To Get A Subpoena For York, Last Year In Another County With A Private Attorney, And Failed To Manipulate The Law.

This Is The Responsibility Of The Building Inspector, Especially With Him Standing Right There In The Flesh, And He, As The Building Inspector, Should Have Been In The Court Room That Day For That Hearing. Why Wasn't He? Where Was He? That Was More Important Than Eatonton's Most Prominent Case, *Attack On The Nuwaubians And All Those Who Sympathize With Them*. In What Appeared To Be Haste And Anger, Mr. Sills Left The Courthouse, Came Back With Citations And Presented Them To Mr. Chism In Another Intimidation Attempt.

These Citations Were Dealing With Permits, That Is, **7.2-Building Permits Required, 7.3-Permit Fees, And 7.4-Permits Application**. Mr. Sills Gave These Citations In A Tone Like *I'm Adding More To This Case*. First He Tried To Hand The Citations To Roy Miller But He Told Sills *I Am Only The Attorney For This Case. I Can Not Accept A Summons For Another Case Unless Mr. Chism Hire Me*.

Sills Then Turned To Mr. Chism And Issued Him Another Summons And Said *This Is To Add To Your Other Summon*. All Of This Was Done In Court While One Trial Was Already Going On. Is This Legal? Are These Unorthodox Actions And Practices Against The Law? Was This Done Out Of Personal Spite For A Man That Mr. Sills Doesn't Even Know? We Will Let The Public Be The Judge On This One. And If You Are Honest, You To Will See That This Is All Being Done Out Of Some Kind Of Spite Or Personal Vendetta. We Will Look To See If They Are Going To Abide By The Law And Have Mr. Chism Tried By A Jury As It States In The Constitution Amendment 7. Or Will They Try To Manipulate The Law And Get Around It.

Not To Mention, That Mr. Chism's First Citation Was Issued **Nov. 13th, Number 01316**. The Next One Was Given To Mr. Chism While In Court On **Dec. 16th, Number 01319**. You Mean To Tell Us That For One Month, Sills Only Issued 4 Citations And 2 Of Them Was For Thomas Chism. Is This Book Of Summons Specially Set Aside For Thomas Chism And People Sills Personally Dislikes? And At The End Of All Of This Drama, When Mr. Chism And Roy Miller Left The Court Room, This Same Unidentified Photographer, Followed Them Out To Their Cars And Continued To Snap Picture After Picture Of Them, Their Cars And Their

**J. D. Adams:** And This House We Got Umm..... What His Umm..... Who Had A Permit?

**Chism:** We Had A Permit, It Was Permitted.

**J. D. Adams:** Did You Say Move Off The Property?

**Chism:** It Was Moved Off The Property From There, Not Off The Property.

**Sills:** My Question...

**Chism:** The Property Is Where It Was At.

**Sills:** My Question Today, Is This Property..

**Chism:** Yes?

**Sills:** This Property, This Piece Of Real Estate, We Are Standing On It Is Not Owned By You At This Time?

**Chism:** No It Is Not Owned By Me.

**Sills:** Then (Demandingly), I Want To See Malachi York.

**Chism:** He's Not Here At This Time.

**Sills:** (Persistently Asking) When Will He Be In?

**Chism:** He Has Nothing To Do With The House.

**Sills:** (Asking Again.) When Will He Be In?

**Chism:** He Had Nothing To Do With The House.

**Sills:** It's His Property.

**Chism:** He's Not Here I Am The One...

**Sills:** What, What I Am Saying Is...

**Chism:** I Am The Spokesman For Malachi's Property

**Sills:** I Understand That. I Understand That He Owns The Property. I Understand That And It's Registered Down....

**Chism:** Anything Happen Down There, I Am The Responsible One For It.

**Sills:** (Aggressively As If He Didn't Hear What Thomas Chism Just Said) What I Am Telling You Is That I Want To See Malachi York, When Do You Expect Him To Be Here?

**Chism:** I Don't Know Where He's At.

**Sills:** (In A Very Demanding Tone) He Owns The Property So That's Who I Want To Talk To Him. Now.....



**Sheriff Howard R. Sills**

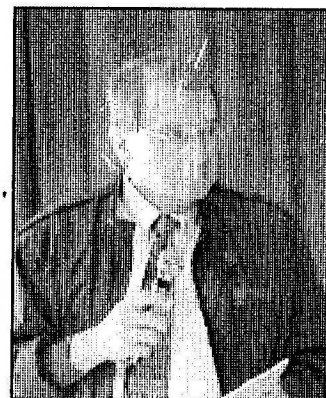
The Sheriff Was First Demanding To Inspect A Lot That We Had A Permit For, And Also The Same Empty House. After They Were Confronted With The Question Of Whether Or Not They Had A Warrant Or The Fact That They Should Have Made An Appointment First, (Because No One Called And Requested An Inspection), The Sheriff Rephrased Their Demand To A Request.

This So-Called Request Was Still In A Very Demanding Way, Nor Was It In His Place To Request An Inspection To Begin With As It Was Made Clear What The Building Inspector Can And Can't Do And What The Code Enforcer Can And Can't Do.

**Detective Lee Wilson** Video Taped The Lot In Question, As Well As Other Things On Malachi's Private Property Without Permission. As You Can Also Plainly See, **Mr. Adams** Didn't Really Have Anything To Say The Entire Time. And Why Was It Necessary For Mr. Sills To Demand To See Malachi York If His Legally Appointed Agent, Mr. Chism Was Standing Right In Front Of Him?

But As You Saw On Several Of The Bulletins In Circulation, And The Article By **Mrs. Brenda Williams**, Which Was Taken From A Video Tape, **Mr. Adam's** Was Not Discussing The Drain Pipes With **Mr. Chism** As The Picture Shows In Video. But Mr. Sills Was Acting In The Capacity Of A Building Inspector As If He Had Been Sent To School For The Proper Training.

By Law According To **The Georgia State Minimum Standard Building Code Chapter 1-Administration Section 102.2.3** Requires "*A Person Shall Not Be Appointed Or Hired As Inspector Of (Any) Construction Who Has Not Had At Least Five Years Experience As A Building Inspector, Engineer, Architect, Or As A Superintendent, Foreman, Or Competent Mechanic In Charge Of Construction...*"

Sheriff Sills Was Appointed A Code Enforcer And Not A Building Inspector. And As A Code Enforcer And Not A Building Inspector, Wouldn't Know What He Is Looking At. But As The Picture And Video Tape Shows, Mr. Adams Standing There With His Hands In His Pockets, Looking In Another Direction, While Sheriff Sills Takes On Mr. Adams' Responsibility And Expertise. Is There Something Wrong With This? We Think So. It Is Clear.

So, With This In Mind, Why Was This Case Filed As A Sheriff Sills' Case, When It Should Be A Mr. Adams' Case? Or Are We At The Same

**Chism:** Did I Rectify?

**Sills:** Are You In Charge Of Putting That Mobile Home Up?

**Chism:** You Ask That Question For What?

**Sills:** Because I Want To Know Whose Responsible For This.

**Chism:** I Just Told You Dr. Kimbrough Who Lives In Atlanta. If You Want To, Contact Him I'll Give You The Number And You Can Call Him.

**Sills:** (In A Very Sarcastic Tone) Well, I'll Get His Number But Now Where Is Malachi York? (Demandingly).

**Chism:** I Don't Know Where He Is.

**Sills:** I Want To Speak With Him.

**Chism:** I Am His Spokesman.

**Sills:** Now You Told Me You Aren't Responsible For Putting That Thing There.

**Chism:** You Asked Me Who Put It There. I Explained Who Put It There. Dr. Kimbrough Has Got The Ok To Sit His House There. You Call Him. He's In Atlanta. He Has The Ok To Put It There.

License Plates, Not Saying A Word, Just Taking Pictures. Is This More Harassment Because **Mr. Ford** Told This Photographer To Make Sure He Took Pictures Of **Mr. Chism**?

These Are The Things That Are Taking Place And How Long Are You, The Public Going To Let It Go On? It Is Because Of This Apparent Personal Dislike And Disregard For The Nuwaubian's Rights, Why **Attorney Roy Miller** Wanted A Jury Of Mr. Chism's Own Peers As The Law Requires, To Hear This Case. So That Liberal Minded, Unbiased Individuals Who Don't Have A Personal Interest Or Disinterest In This Case, Be The Judge. They Have Opened The Door To The Cover Up. All Of Those Who Are Involved Are Going To Fall While Trying To Protect This One Man Who Is Known To Bend The Law And Find Ways Of Getting Around The Law And Procedures.

Is It Really Worth Facing Serious Charges Or Perjury On Behalf Of This Man? This Would Explain Why The Nuwaubians And Other Citizens Of Eatonton, Who Are Not A Part Of Their Vicious Clique, Can't Get A Fair Hearing In This Town. Remember, All The Nuwaubians Asked For Was A Fair And Honest Hearing.

So All Of This Just To Protect One Man And Support Him In His Biasness And Apparently Blatant Disregard For The Laws (When You Know In Your Hearts That It Is Wrong) Could Affect Your Careers, Futures, Family Etc. These People Must Ask Themselves, Is It Worth It? Is The Anger Of **Dorothy Adams, Francis Nearn Ford** And **Howard Richard Sills** Worth It? Is It Worth All Of The Headaches And Unnecessary Words Being Said?

Everybody Knows That The Nuwaubians Don't Bother Anyone. Their Neighbors Have Said Repeatedly That They Keep To Themselves And Are A Pleasant People. This Whole Thing Was Started By Certain Officials, Who, For Some Strange Reason, Wanted Someone To Pick On While They Could Be Helping To Solve Some Of The Real Cases In Town Or Is It For The "Fine" Money?
