Anyone Could See That This Should Be Questioned. Well Thought Out Schemes And Even Bogus Articles Could Be Created, Knowing That, That Would Draw The Attention Of The Media. It Seems To Us That A Lot Of Officials Are Being Manipulated And Used By An Individual. We Wonder, What

Kind Of Control Is Being Used? But We Guarantee You. The Investigations Will Go On Until We Get To The Bottom Of This. Because Too Many People's Lives Are Being Affected And No One Individual, Sane Or Insane, Has The Right To Terrorize: Not Here In America. Home Of The Brave. Land Of The Free. We Have Rights. SILLS: SUIT OR FLUKE?

From The Thursday, December 10. 1998 A.D. Article In *The Eatonton Messenger*, Entitled, "Sills To File Suit Over Phony News Clipping." It Is Clear That This Is Just Another Scheme To Draw Attention Away From The Facts. The Article, Written By Rob Peecher, Literally States "Please Download The Two Part Article, Read It, Investigate It..." The Point Is, It Says Two Part Article Not Newspaper As Judy Bailey From *The Union Recorder* Called It In Her Article Entitled, "Mass Email To Media Targets Sills-Internet Message Includes Fake Newspaper Masthead" On Friday, December 4, 1998 A.D.

So, Whoever Downloaded It Clearly Intended For It To Be Used As An Article And Not A Newspaper. The Question Is, When Mrs. Brenda Williams Was Standing In Front Of Judy Bailey, Which Gave Birth To This Whole Situation, Was Mrs. Williams Presenting A Whole Newspaper Or A Typed Written Article? A Simple Yes Or No From Mrs. Bailey Will Suffice, But An Answer Is Necessary. Evasion Of The Answer Is A Confession Of Compliance To Mis-Information Being Circulated. Our Staff Has Already Questioned Mrs. Williams About This And She Made It Very Clear To Us That She Presented A Typed Written Article, Not A Newspaper With A Heading As A Single Page, Or Full Newspaper, Or Two Articles, But One Typed Written Article.

She Simply Had An "Article" That She Wanted To Pay To Put In *The Union Recorder*, Not Two Articles As Mentioned By Rob Peecher, But One Article. Again, We're Asking Mrs. Bailey To "Set The Record Straight." Did She Present You A Newspaper, Two Articles Or One Article? We Need Clarification. This Type Of Investigation Will Bring Us Closer To Who May Be Responsible For This Hoax, And What Their Hidden Agenda May Be. Is It Simply To Get More Media Attention Or Is It Another Plot To Undermine The People Of Eatonton?

If Brenda Williams Had In Her Hand An Illegal Newspaper Entitled, *The Eatonton News*, With Official Organ Of Putnam County Attached To It, Wouldn't Mrs. Bailey Have An Obligation To Immediately Call Her Law Enforcement Friend, Mr. Sills? Or At Least Call *The Eatonton Messenger* To Find Out Whether Or Not They Have Put Out A New Newspaper Under The Title The Eatonton News? Mrs. Bailey Should Be Asked, "Just Who Did You Call Or Speak With First?" (Being Under Oath Might Encourage Truthfulness.) As A Professional Managing Editor Of *The Union Recorder*, Wouldn't She Have Recognized That This Person Was Standing In Front Of Her With An Illegal Newspaper? It Is Apparent From This That There Was No Illegal Newspaper.

So She Too, Prior To Her Article Entitled, "Mass Email To Media Targets Sills-Internet Message Includes Fake Newspaper Masthead." Recognized That Brenda Williams Was Presenting Her With Just One Article, And A Power Packed Article I Might Add. Which Is Why It's Drawing So Much Attention. The Article By Brenda Williams Is Saying That "Investigators Did Research On Sheriff Sills' Domestic Trauma." When In Fact It Should Read "Tried" To Investigate Because To Their Surprise A Simple Divorce Case Is Being Kept Under Lock And Key For Some Mysterious Reason. Most Divorce Cases Are Public Records. So, Why The Great Secret? What's Hidden? What Is It That They're Trying To Keep The Public From Knowing? This Is What **C.C.O.E.** Think Ms. William's Article Is Stating.

The Concerned Citizens Of Eatonton Are Not Trying To Invade His Privacy, But His Divorce Is A Very Important Issue. We Repeat, Most Divorce Records Are Generally A Public Record. That's Why It's Strange To Us That There Is A Court Order For This Specific Divorce Case To Be Locked Away. Why? Why Keep These Files From Being Opened? Was Their Domestic Violence, Illegal Activity, Or Adultery? Who Were The Court Officers, The Lawyers, And Witnesses? The Time Factor Of The Divorce Is A Relevant Issue Too. When Was It Initiated And When Did It End? At The Time When He Was Appointed As Code Enforcer, In March 1998. Was He Capable Of Performing His Job Or Was He Taunted By This Trauma Of Divorce? The Lives Of The Citizens Of Putnam County Could Have Been Greatly Affected By The State Of Mind That He May Have Been In During The Proceedings.

Emotional Stress Can Cause You To Behave And Do Irrational Or Illogical Things. Our Lives Could Have Been Seriously Affected By What Our Sheriff Was Going Through. Did He Cite The Nuwaubians For A Permitted Use During The Time That He Was Going Through This Trauma. And Was He Taking His Anger Or Frustration From The Situation Out On The Nuwaubians? We, As Concerned Citizens Of Eatonton, Feel It Is Our Right To Want To Know About His Mental Condition, Being That He's A Public Servant Walking Around With A Legal Firearm And The Authority To Arrest. All We Are Saying Is That Sheriff Howard R. Sills' Emotional Stability Needs To Be Evaluated, Just Like Any Other Human Being That Could Have Gone Through The Same Type Of Trauma. Yet, This Inquiry Is Being Avoided Intentionally And The Attention Is Being Shifted To Insignificant Points About The Authenticity Of A Newspaper. And They Even Stated Themselves That The Author Of The Article, Brenda Williams, Denied Having Anything To Do With The Mass Email. They Want The Public To Focus On The Fact That There Was A "Phony" Newspaper, Instead Of What Is Actually Written In The Article And The Many Laws That Are Constantly Being Violated.

Whenever A Sheriff Or Any Other Elected Public Official Who Is Supposed To Stand For Justice Makes An

Accusation, People Believe Them Because They Have Been Trained In America To Trust Public Servants. They Are Supposed To Stand Behind A Badge Of Justice, Principles And Honor. This Isn't Hypotheticals, These Are Real Situations. Just Like In Millner, Georgia, Where A Police Officer Named David Mc Clendon Harassed And Interrogated A Citizen Over A Period Of Time. This Was Reported On December 9th, On WMAZ Channel 13 At 10:00 P.M. This Officer Went As Far As Accusing This Man Of Shooting Him. However, As The Case Went On, The Police Officer Was Found To Have Been In The Wrong From The Beginning. He Was Charged With Giving False Testimony, Interfering With Government Property, And Tampering With Evidence. The Chief Of The Police, His Superior, Was Reported As Saying David McClendon Was Always A Good Officer And He Had No Reason To Doubt Him. These Things Are Happening Right Now. The Public Has Been Conditioned To The Good Guy Vs. Bad Guy Syndrome Through Movies: Especially Old Cowboy Movies. By That We Mean, When An Official Makes Statements And Calls Someone A 'Bad Guy', It Affects People's Lives Because The Public Has Been Trained To Listen, Trust, And Believe Whatever That Official Says. This Is Because The Public Pays Taxes To These Officials To Protect Them And Thus Need To Trust Them. It Is Only Revealed Sometimes In Movies That The Character Who Was Supposed To Be The Good Guy Is Really The Corrupt Guy.

As Time Has Proven, There Have Been Elected Officials Who Are Spies, Revealing Secrets To The Adversary, Police Officers Who Are Corrupt, And Abuse Their Authority Such As In The Rodney King, Abner Louima, And Tawana Brawley Cases. And Unfortunately, These Crimes Are Predominately Against Negroes And Mexicans, And Even In Many Cases, Involved Poor Caucasian People That Result In Abuse And Violence. Article In *The Eatonton Messenger*, By Rob Peecher On Page 14A. You'll Clearly See "Download The Two Part Article," Not Newspaper Entitled *The Eatonton News*. They Know That The Concerned Citizens Of Eatonton Are Closely Monitoring And Analyzing Everything They Say And That Some Of Us Are Lawyers And Investigators. We Are Investigating Every Name That Comes Up That Appears To Be Constituents Of Sheriff Sills, Whom We Suspect Is Not Competent, And They Know That We Are Literate And Articulate People Who Respond To Everything They Say By Way Of Newspapers, Flyers, Pamphlets, Radio And Even Television, So That The Public Can Be Aware Of The Possible Dangers They Are In.

The Union Recorder Article By Judy Bailey Dated Dec. 4, 1998 On The Front Page (1A) States That Mr. Sills Is One Of The Three County Officials Who Designates The Official Organ Of The County. What Does This Mean? It Means That He Is One Of Those In Control Over Which Newspaper Gets The Right To Be Called The Official Organ. Could This Be The Reason Why *The Eatonton Messenger* Seems To Comply And Print Articles In His Favor? Another Question We Have Is Why Does *The Eatonton Messenger* Now Have Something To Say About This Mass Email When In The Same Article By Judy Bailey, She States That Mr. Mark Smith Had No Comment. The Accusation Was Made That The Masthead Of *The Eatonton News* Was A Copy Of *The Eatonton Messenger*, So Why Is It That The Owner Of *The Eatonton Messenger*, First Declined To Make A Statement To *The Union Recorder* And Then Later States In *The Eatonton Messenger*, Dec. 10, 1998 Edition, That He "May" File A Suit. All Of The Sudden Either He Changed His Mind Or His Mind Was Changed By Some Person Or Persons With Great Influence? We Really Wonder If Someone "Strong Armed" *The Eatonton Messenger* Into Printing An Article About This "Alleged" Copyright Violation And Now Wanting To File Suit Giving Them A New Outlook, Which They Will Probably Have To Refute In Another Article Just To Cover For Another, And We Do Understand Pressure By Those In Authority.

Could This Influence Be The Reason Why There Hasn't Been A Fair Article Published In *The Eatonton Messenger* About The Unjust And Illegal Treatment That The Nuwaubians Are Receiving To This Day? ④
