

Sills - "Ms. Hibner, How Are You Doing, I'm The Sheriff (*This Man Has A Major Problem Because He Just Used His Title "The Sheriff" Without Stating His Full Name Or The County To Intimidate Ms. Hibner*), **Your Mother** And Your Aunt Are Very Concerned About You, And Wanted Me To Check On You. What's Your Birthdate?" **Ms. Hibner** - "December 16, 1975." (*Which Gives The Age Of 22. Which Is Four Years Older Than 18. This Should Have Immediately Registered In The Sheriff's Mind And He Would Have Left On The Spot*)

Sills - "Your Mother's In Africa, Did You Know That?" **Ms. Hibner** - "Yes, She's In Niger." (*Because Her Mother Was Over Seas In Niger, Africa. She Was Very Concerned About Her Mother's Well Being. She Thought That Maybe Something Had Happened To Her Mother With The September Bombing And All.*)

Sills - "Well, She (Your Mother) Wants You To Call. I'm Not Saying You Have To Call, But She's Very Concerned About You. Are You Here On Your Own Free Will?"

Ms. Hibner - (*At This Point She Was Highly Insulted, But Still Answered*) "Yes."

Sills - "No Problems?"

Ms. Hibner - "No Problems"

With That, Sheriff Sills And Jerome Adams Left The Premises. After The Sheriff Left, Robbie Called Her Mother In Africa And Her Mother Said That She Hadn't Made A Call To Sheriff Sills Or Her Aunt. Mrs. Hibner Found Out That It Was Her Aunt Who Had Made The Call. **Sheriff Sills Intentionally And Repeatedly Lied To Her Saying Your "Mother"**. This Is A Nice Story Right? Now Let's Take A Look At This From A Legal Point Of View.

A. Robbie's Mother Never Called, And Sheriff Howard R. Sills Lied And Told Her That She Did. (*We Have Her Aunt's Phone Records Which Proves That It Was Her Aunt Who Called.*)

B. There Is A Law That States That In Order To File A Missing Person's Report, The Person Had To Be Residing With The Person Filing The Report, 7 Days Prior To Filing. Then The Police Are Obligated To Wait An Additional 48 Hours Before They Take Any Action. Mrs. Hibner Has Her Own Apartment In Milledgeville And Stays On Tama-Re During The Week When She Works. Her Legal Residence Is Milledgeville Not Salisbury, North Carolina (*Where Her Aunt Lives And Never Was.*), So Why Didn't The Sheriff Check That Location First? She Could Have Been Anywhere In The United States, Because She Is Not Obligated To Be Here, She Merely Volunteers Her Time As A Worker.

C. A Missing Person's Report Has To Be Filed. No Such Report Was Filed In This Case And The Sheriff

But That Goes To Show That It Wasn't Concern That Prompted Her Call, It Was Shear Nosiness. Robbie's Mother Was Here For The Savior's Week Festival In June And She Saw Her Daughter With Her Own Eyes. The Fact Is That Robbie's Mother Is Not A Member But Is A Sympathizer And Even Reads Some Of Our Books. The Sheriff Purposely Misinformed Us About The Person Inquiring About Her By Adding "Your Mother" And His Reason For Being Here.

Even Though At First It Is Hard For The Non-Nuwaubian Relatives Of Our Organization To Get Use To The Way Of Life We Have Chosen, **Most Eventually Come Out To The Land And Meet Our Members For Themselves And Are Impressed.** We Promote Family Life And Are Not Some Youth Organization Whose Members Are Between The Ages Of 18-25. If You Come Out And See For Yourself, You Will See That Our Members Belong To Fourth Generation Nuwaubian Families. That Means That The Child, Parents, Grandparents And Even Great Grandparents Are All Members Of Our Organization. We Are Not New. We Existed Since 1967 A.D. Many Children Grew Up Here.

Most Parents Are Proud Because They See That Their Children Have Made A Good Choice And Are Living A Healthy And Productive Life. They Appreciate The Example That Their Children Are Setting. In Other Words, They Know That There Are A Lot Of Other Things That Their Children Could Be Doing But They Come To Realize That Everything That Takes Place Here Is Positive. Some Parents Come To Visit Their Children That Use To Be Drug Addicts, Criminals Etc. And See That A Change Has Occurred In Their Lives And Are Impressed. Most Become Members Themselves, But Those That Do Not Become Members Are Sympathizers And Look Forward To The Yearly Family Reunion In June.

The Nuwaubians And Their Non-Nuwaubian Family Members

Ridiculous And Unfounded Rumors Have Been Circulating About Tama-Re, Egypt Of The West, The Nuwaubians, Or The "Pyramid People," As We Have Been Called By Many. One Of The Silliest Of Them All Is That People Are Being Held Against Their Will. In Other Words, They Are Being Held Hostage. We Would Like To Make This Clear...**THERE IS NO ONE BEING HELD ON TAMA-RE, EGYPT OF THE WEST AGAINST THEIR WILL.**

These Kinds Of Rumors Have Been Started By Our Super Cop "Friend". He Creates Them So He Can Violate Our Privacy Rights And Barge Onto Our Land Whenever He Feels Like It, Under The Pretense That He's Looking For Someone.

There Are People All Over The World That Are Firm Believers In The Faith That They Have Chosen. And This Is Their God Given Right, In America, Their Constitutional Right... It's Called Freedom Of Choice. Christians Believe That All Non Christians Are Going To Hell. Muslims Believe That All Non Muslims Are Going To Jahanam (Hell) And Jews Believe That All Non-Jews Are Going To Sheol (Hell).

In Order For Them To Be True Believers, They Must Believe That All Sinners (According To Whatever Definition They Use For A Sinner) Are Going To Hell, And They Can't Make An Exception For Their Children And Family Members That Do Not Believe. Because They Are "Concerned" For The Well Being Of Their Children, Some Parents Will Stop At Nothing To Make Their Children Believe The Way They Do. Christian Ministers Preach That When You Get To Heaven, You Will See Your Family Members That Have Died. Because Of The Attachment That Most Family Members Tend To Make, They Want To Be Sure That Their Whole Family Is Going To Be There, "*When We All Get To Heaven*".

It's Obvious That We Don't Follow The "Average" System. Our Customs Are A Lot Different Than Most

Other Customs. We Have Our Own Marriage Ceremonies And Even Our Own Easter, Halloween, Thanksgiving, Christmas, And New Year's Eve. It Is Therefore Hard For Parents To Understand When A Nuwaubian Chooses Not To Participate In The Holiday Gatherings That They Have Participated In Their Whole Life, And Rather Chooses To Participate In Nuwaubian Festivals, Gatherings And Customs. This Is Because They Don't Understand The Real Reasons Why "Jr" Doesn't Come Home For Christmas. They Assume Or Start Making Accusations That Their Child Has Been "Brainwashed," Or Belongs To Some Fanatical Cult That Tells Them What To Do. They Begin To Really Believe This, Just As Strongly As They Believe In Their Religion, And Will Do Whatever Possible To Try To Change Their Child's Mind. Even If It Means Violating The Law And Violating Their Child's Civil Rights.

Some Parents Have "Cult Busters" Kidnap And Hold Their Child Against Will. Their Grown Child Who Is Old Enough To Make Decisions On Their Own. You're An Adult In This Country At 18 Years Old, Yet Relatives Will Call The Sheriff And Say You're Missing. Then, He Will Actually Ignore The Law That States That You're An Adult At 18, And Come And Question You As If You're A Minor. He Will Even Harass The Institutional Organization That You Belong To As If You're Being Held Against Your Own Will. Yet, You Have Your Own Free Will Because You Are An Adult.

Now, I Keep Using The Word Child For A Reason. No One Is Allowed To Move To Tama-Re, Egypt Of The West That Is Under 18, Unless We Have The Written Consent Of Their Parent Or Legal Guardian. The Children That Are Here Belong To "Grown Adults" Who Have Made The Choice To Be Nuwaubians. However, The Parents Of These "Grown Adults" Still See Them As Their "Children," And Not Consenting Adults Capable Of Making Their Own Decisions. Nuwaubians Are Insulted When They Are Confronted With Accusations That They Belong To Some Fanatical Cult, Are Brainwashed, Or Are Being Told By One Man What To Do. This Is Because Being A Part Of Nuwaubu, Which Is Our Way Of Life, **Teaches You How To Think, Not What To Think.** THERE IS A BIG DIFFERENCE!!!

The Difference Is That Nuwaubians Are Taught By The 24 ELDERS To Check Out And Research Everything. That's The Problem That Most People Have With Us, **We Know How To Think For Ourselves.** We Don't Just Accept What Someone Says Without Being Given Proof To Back It Up. We Don't Even Want To Hear It From Our Non-Nuwaubian Family Members, Because That's What Causes The Problems. There Is Only A Small

Amount Of Parents Who Are Not With Our Organization. You See, Some Parents Are Used To Telling Their Children What To Do And Not Being Questioned About It. However, We Ask Questions. It's Sad To Say That A Lot Of Non-Nuwaubian Parents Feel That Someone Else Is Taking Their Place As The Controller Over Their Child's Life! So, They Are Jealous, But This Is Just Not The Case. Our Members Are Encouraged To Take Charge Of Their Own Lives And Not To Depend On Anyone Else. Most Parents Have Already Planned The Life For Their Children. They Say Susie Is Going To Go To College To Become A Teacher, Whether They Know What Susie Wants Or Not. We Teach Susie To Make Her Own Decision About Her Life, Which Is What Her Parents Should Have Taught Her, Instead Of Trying To Re-Live Their Lives And Dreams Through Her. The Small Amount (And I Do Mean Small Amount) Of Parents That Do Not Support Us Will Not Even Give Susie The Opportunity To Explain What She's Involved In, And Show That She Is An Adult. These Few Parents Want Their Children To Stay Children Forever.

There Were Only Two Occasions Over 6 Years Of Being In Georgia Where Non-Nuwaubian Family Members (Who Were So Called "Concerned" With The Well Being Of Their Nuwaubian Family Member That Live On Tama-Re) Have Called The Sheriff To Go "Check" On Their Relative. One Example: A Grown Woman By The Name Of Natasha Corbett, Age 22, Married To Clifton Cutrary, Age 26. They Both Came To Georgia From New York To Live On The Land. Her Mother Was Dissatisfied With The Choice Her Daughter And Son-In-Law Made. Even Though They Were Not Living With Her When They Came To Georgia.

Natasha's Mother Brought The Then Sheriff Eugene Resseau, That Was In 1995 Out To The Land, Because She Wanted To See Her Daughter, Who She Said Was Being Held Against Her Will. They Walked Around Freely And Talked With Natasha And Even Met Rev. Malachi York. They Had A Nice Time, Apologized, Then Returned For The Annual Family Reunion Celebration, And They Had A Wonderful Time. Natasha's Mother Realized How Silly She Was To Think That She Actually Needed The Sheriff To Be Allowed On The Land, And Admitted That She Had Believed The False Rumors That Were Being Spread About Us. To Date, Natasha, Her Mother, And Even Her Sister, Are Members Of Our Organization.

Another Instance Happened On October 1, 1998 A.D. Between 10:30-11:00 A.M. This Is The Dialogue That Was Transcribed Off The Video Tape Of The Incident.

Sheriff Howard R. Sills - (Speaking To The Head Of Our Security Guard, Claude Turner) - "I'm Here To See Robbie Hibner. If She's Here I Just Need To Talk To Her And Ask Her If She's O.K." (**Let's Make It Clear... The Sheriff Doesn't Really Care About The Well Being Of Robbie Hibner And For Him To Pretend He Does Is Utterly Absurd!!**)

Mr. Turner - "Who Is It That Wants Her To Contact Them?"

Sills - "Well, Her Aunt Called. **Well, It's Her Mother** And Her Aunt. What I'm Saying Is All I Need To Do Is To Simply See This Woman."

Mr. Turner - "I'll Contact The Office And Have Her Contact You."

Sills - "I Don't Think You Understand What I'm Saying. What I'm Saying Is, This Lady's (**Notice That He Himself Has Used The Words Woman And Lady**) **Mother Has Called** And Her Aunt, Her Mother's In The Armed Service In Africa And She Says That She Has Not Heard From Her Daughter Since August 12th." (**Note: She Was Not Living With Her Aunt Or Mother When She Joined The Nuwaubians.**)

Turner - "Okay Give Us The Number And We'll Have Her Call."

Sills - "**THEY** Want Me To Check On Her Well Being And Have Her Call Her Folks...I Understand This Has Happened Before." (*He Was Referring To The Natasha Corbett Incident Of 1995.*)

Mr. Turner - "What Name Do I Tell Her Wants To Contact Her?"

Sills - "Her **Aunt**, Linda Dillard." (**Note: Not Her Mother.**)

While They Were Waiting On Robbie To Come Out, Mr. Jerome Adams, The Building Inspector, Began Asking Questions About The Permit For A Plat Next To Hathor Recording Studio (**So We've Come To The Real Reason For The Visit**). First Of All, Why Was The Building Inspector There When The Sheriff's Reason For Being On Our Land Had Nothing To Do With Planning And Zoning. It's Obvious That The Real Reason They Were Here Was To Look For Something Else To Accuse Us Of. Come To Find Out, **The Permit That He Was Asking About Was Already On File In His Office** Per Marianne Tanner, His Personal Secretary. (He Looked So Ridiculous On Tape, Asking About Something He Signed Himself. He Too, Realized That This Entire Situation Is Ridiculous As Well And Is Getting A Little Out Of Hand)

Robbie Hibner, A 22 Year Old Housewife And Mother Of A 3 Month Old Baby, Unwillingly Lefther Daughter In Fear To Come Outside And See What The Sheriff Wanted. Because He Made It Appear That If She Didn't, The Incident Would Escalate.
